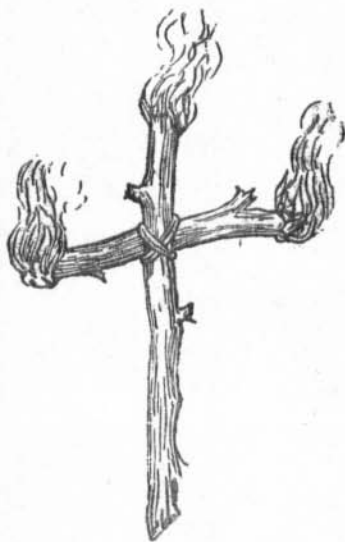

## REPORT OF THE DEPUTY SCRIBE

October 17, 1947

Memory brings to my mind our first Chieftain, Dr. Edward May Magruder; Dr. Stuart Muncaster; Mr. Alexander Muncaster, my own beloved husband, Clement William Sheriff; Mr. P. H. Sheriff; their esteemed cousin, Mary T. Hill; Miss Mary Magruder; Mr. Caleb Clarke Magruder who served the Clan as Historian, Editor and Chieftain. I have sent cards to all officers and members of the council and have enjoyed serving for many years as Deputy Scribe, charter, and associate member. I do not recall having missed over two gatherings since the Clan was organized and my fellow councilmen—this is my “Swan Song”, I am giving in my resignation today, as Deputy Scribe, to take effect at this meeting.

The meeting of the Committee for Future Planning was called to order by Mr. Herbert T. Magruder, Chairman, on Friday, October 17, 1947, at 11 A.M. Those present were: Mr. Herbert T. Neil Magruder, Mr. Henry Magruder Taylor, Mrs. Rosalind G. Magruder, Mrs. Thomas B. O'Loughlin, Mrs. Frederick Baugh, Miss Rebecca M. MacGregor, and the Council members, who were not members of the Committee, sat with the Committee.

Mr. Magruder read his report as Chairman of the Committee and also the report of Miss Dorothy T. Magruder, Treasurer. Both were accepted and made a part of these minutes.

In connection with the foundation fund, Mrs. van den Berg was authorized to order ten additional Coats of Arms.

It was Commodore Magruder's suggestion that advertising might be used in the Year Book, this, of course, to be of a type in keeping with the dignity of the book. Such advertising is used by the Maryland Historical Society, and it was the feeling of the Committee that it would be worth trying for our publication. It was thought that notice should appear also in the Year Book, as a reminder to all, of the plan to augment this fund by popular subscription, legacies, memorial gifts, etc.

Mr. Herbert T. Magruder requested that a new Chairman for the Committee for Future Planning be appointed in his place.

Mr. Douglas Neil Magruder moved the appointment of Commodore John Holmes Magruder, Jr., as Chairman for the coming year. The motion was seconded and carried.

Miss Dorothy T. Magruder wished to be relieved of the duties of Committee Treasurer. The motion was made and seconded that Mrs. Rosalind G. Magruder be appointed Committee Treasurer for the coming year. Motion carried.

In closing, Commodore Magruder expressed great interest in the purpose of the Committee, and he recommended soliciting the aid of all who might be helpful in carrying out its work. He proposed conferring throughout the

year with members of the Committee who also live in Washington, and it is his desire that other members keep in touch with him on any matters that will further the plan for a growing fund.

Upon motion the meeting adjourned.

## REPORT OF THE COMMITTEE FOR FUTURE PLANING AMERICAN CLAN GREGOR SOCIETY

OCTOBER 17, 1947

As reported last year the following needs exist for future advancement of American Clan Gregor Society. They bear repeating.

- 1—Placing Year Books in a greater number of Libraries.
- 2—Photostating Old Family Bible Records, Wills, Land Grants, Marriage Bonds and Genealogical Charts.
- 3—Cuts of Historic Photographs.
- 4—Binding the Society's Membership and Genealogical Records.
- 5—Preparation of a Comprehensive Index of Year Books and other Data.
- 6—As an Ultimate Objective the Acquisition of an Old Maryland Home for the Society's Headquarters.

A start has been made towards the realization of these objectives. Much more is to be done; and there are these other urgent needs.

- (a) More Members who will become actively interested.
- (b) More prompt payment of dues by present members.

Our Society is Nationwide in scope. It should become more Nationwide in active participation by its members. It was wisely planned to hold our Annual Gatherings here in the Nation's Capital, so close to the roots of our family in America. But the responsibility of working actively for American Clan Gregor Society should not rest so largely on the shoulders of the loyal group of Washingtonians, who do most of the planning and laboring for the Clan. The Coat of Arms project, originated by the Registrar, Mrs. van den Berg, has proven quite a successful activity, as you will note from the Report of the Treasurer of this Committee.

Several other suggestions have been made, but the means of accomplishing hoped for results have not developed. It is a disappointment to your Committee that no additional Memorial Gifts have been received this year. Nor have any bequests come to our Society from those who have gone to answer the call to that Greater Gathering of loyal spirits. A remembrance of this sort, even small in amount, would show enduring love for the spirit of Clanship we all cherish so dearly.

But great as is the need for additional capital funds, the need for active, zealous interest in Clanship, and individual effort to sustain our Society is even greater. We have no mean history of achievement during the 38 years

since its Founding. If each member will assume responsibility for a share in its sound development, a long and successful future lies ahead. Will you not resolve to do your share?

THE AMERICAN CLAN GREGOR SOCIETY

ROCK CREEK PARISH HOUSE, WASHINGTON, D. C.

FRIDAY AND SATURDAY, 17-18 OCTOBER, 1947

The 38th Annual Gathering of the American Clan Gregor Society was called to order by the Chieftain, Frank Cecil Magruder.

Acknowledgements are made to Mrs. Frank Pelham Stone, Shaffer, Inc., Florist, and Miss Rebecca MacGregor, for pine boughs and floral decorations.

The Chieftain's address and report is published elsewhere in this pamphlet. Greetings were read from absent members and noted elsewhere. Reports were read by the Treasurer, Historian and Registrar, and Chairmen of Special Committees. These reports were approved and made a part of the official proceedings.

Resolutions were adopted by the gathering as approved by the Council. Formal publication of these will appear in the revised Rules when published. Changes in the Rules are as follows:

Resolved—That Section 2 of Rule VI be amended by changing the Words "twenty-five" in the first line to "one hundred". Also amend Section V of Rule III in the same manner. (That is, that Life Membership be raised to \$100.00.)

Resolved—That Section 3 of Rule VI be amended by changing "Minor Member" to "Junior Member" and adding the words "shall be required to pay dues of 50 cents per annum, "in place of the words "shall not be required to pay dues."

Addition to Rule XIX—

The Treasurer shall annually withdraw from the amount held in the Savings Account to the credit of Life Memberships the sum of One (1) Dollar and Fifty (50) Cents for each living Life Member and transfer the same to the General fund to be used in the annual expense of the Society.

Revision of Rule XXIX—

The Editor shall have printed bi-annually a number of Year Books sufficient to send one to each voting member, one to each State Public Library, one to each Society affiliated with this Society, two for copywriting, one to the National Society of the Sons of the American Revolution, one to the National Society Daughters of the American Revolution, all to be sent by him free of charge; ten for the Archives of the Society, and fifty to be turned over by him to the Treasurer for sale to members at One (1) Dollar per copy, and to non-members at One and one-half (1½) Dollars per copy. These Year Books to be bound in the familiar Red cover as previously issued will be published following the gathering in

the *even* years. During the interim, or reports of the *odd* years, only the record of the proceedings of the meeting, changes in membership, notices of deaths, births and other items of interim interest will be published, in as inexpensive form as possible and mailed to each voting member.

The session adjourned to the dinning room where luncheon was served by the Ladies of the Guild.

Devotional services were conducted by Rev. Enoch Magruder Thompson in the Parish Church and the group then moved to the site of the Memorial Tree in the churchyard where a commemorative pine bough tied with the Clan ribbon was laid by Mrs. Philip Hill Sheriff.

Those who attended the afternoon session heard the various reports read and a delightful set of verses submitted by Kenneth Dann Magruder, and read by Herbert Thomas Magruder.

The evening session was called to order by the Chieftain at 8:00 P.M. True Scottish music was furnished by the Pipers, James Garriock and our Clan member, William Lachlin Kennedy Galloway. A Memorial Paper on the life of Egbert Watson Magruder, a past Chieftain of the Clan, was read by Henry Magruder Taylor. (This paper will be printed in the next Year Book.) Vol. XXXIII.

Commodore John Holmes Magruder, Jr., gave greetings and introduced the guest speaker, Mrs. Garnet Hulings of Cockeysville, Md., a member of the Society for the Preservation of Maryland Antiquities.

Mrs. William Henry Meyers entertained by playing one of her own piano compositions.

The Program Committee arranged for two educational films in technicolor. The first was the story of apple growing and processing and the second was a travelope of "America The Beautiful."

Mr. William Marion Magruder presented the Report of the Nominating Committee and moved its adoption.

The Chieftain asked for nominations from the floor. There being none, he presented the report of the Nominating Committee for a vote.

It was moved and seconded that the Ticket as presented be adopted. Miss Rebecca MacGregor, who was on the Ticket for the position as Deputy Scribe, declined. Miss Elsie Thrift was nominated from the floor for this position.

## REPORT OF THE CHIEFTAIN

MR. FRANK CECIL MAGRUDER

It was with considerable hesitancy that I accepted the office of the Chieftain a year ago. But I did; with the understanding that I would do the best I could; and I knew at the time that I was not perfect and that there were those in the Clan who had ideas about its affairs which were considerably different from mine. I also knew that a great many members of our Clan had ceased to pay dues and had ceased to take any active part in the activities of the Clan.

We started the year with a balance in the Bank of \$58.70, according to the treasurer's report of October 1946, and though the treasurer has worked like a "trojan" our income has barely kept pace with our expenditures.

The Doctor Edward May Magruder Scholarship in the School of Medicine at the University of Virginia amounting to \$50.00 was given to Nathaniel McGregor Ewell, Jr., again this year. Mr. Ewell graduated in June of this year and so far no one has made application to receive the Scholarship. The amount in the fund originally was \$1,200.00, which at the rate of interest set up by the University amounted to \$50.00 each year. There have been some years that there was no eligible person in the College of Medicine at the University. As a result of that condition the money for that year was not used.

During my correspondence with the Bursar of the University I learned that there was a balance of unused funds of \$150.00. The question then arose as to whether to give this balance to the recipient of the first \$50.00 or to carry it over and add it to the original or principal amount. This matter was taken up with the members of the Council and the majority opinion was that any unused funds any year should be added to the principal sum. I wrote the Bursar accordingly and he advised me later that our wishes would be complied with and that on June 30, 1947, there would be added to the principal the sum of \$200.00. This makes the principal sum now in the Scholarship fund at the University \$1,400.00. This amount is to draw 4% interest.

By letter of December 20, 1946, Mr. John Bowie Ferneyhough sent me his resignation as Editor of the Clan. He stated that he was working very hard and that there was sickness in his family, making it impossible for him to continue as Editor. The matter was taken up with Miss Hill and Mrs. van den Berg and some inquiry was made to find some one who would be able and willing to take over the job. After a little futile search and some correspondence, we did not find any one to take over the job. We decided that the only thing to do was for us to get out the Year Book. Myself acting Editor.

We begun by Miss Hill and Mrs. van den Berg getting material together and I looking about for a printing firm to do the printing, binding, etc. for us. I received bids on the work running all the way from \$5.50 per page to \$14.50 per page based on 500 books. Washington printers were the highest, Baltimore next and Richmond the cheapest. We contracted the work with Cussons, May and Company as you will see in your Year Books. There was considerable

correspondence regarding the size of type to be used. The larger type preferred by some as being more easily read could be secured for \$4.50 per page and the smaller type (as finally decided on) could be secured for \$5.50 per page. There was not much difference in cost as the printers could get so many more letters on a page of the smaller type than they could of the larger type. However there was some slight saving in postage as the smaller type made less pages, so weighed less, and took less postage. We inveigled the Government into shipping them for 4c, which was much less than what was paid for postage on the books a year ago. The printers gave us 520 books without any charge for the extra 20 books. The cost of the books amounted to about \$1.27 each. 425 books were mailed out and some 18 or twenty were returned for various reasons, principally because the party had moved and left no address. Addresses were found for most of them and the books remailed to the new addresses.

Martha D. Magruder has been most helpful to me during the year, being custodian of the clan property, keeping the rats, moths and so forth out of it; she and I decorated the hall yesterday afternoon and evening. She also addressed all of the envelopes for mailing out programs and notices of this Gathering, also addressed all of the envelopes for mailing out the Year Books; arranged for the use of the Guild Hall today and arranged for the luncheon.

Back to the Editing of the Year Book again. I want to tell you of some of our experiences. Miss Hill had prepared a wonderfully nice report of each of our service people and we had several articles submitted for publication in the Year Book. When I begun to get prices and figure up the pages I found that we had material enough for about 225 pages. So we had to begin revising. Miss Hill completely rewrote the articles about the service men, other articles were rewritten and reduced in size, and still other articles were not published at all. In fact I have enough material to make another Year Book of about the same size as the one printed. This material I will turn over to the new Editor and he can do as he likes about printing it. Only one of the articles submitted for the Year Book and which was not printed has been withdrawn. It will be the discession of the writer whether she wishes to resubmit it again or not.
