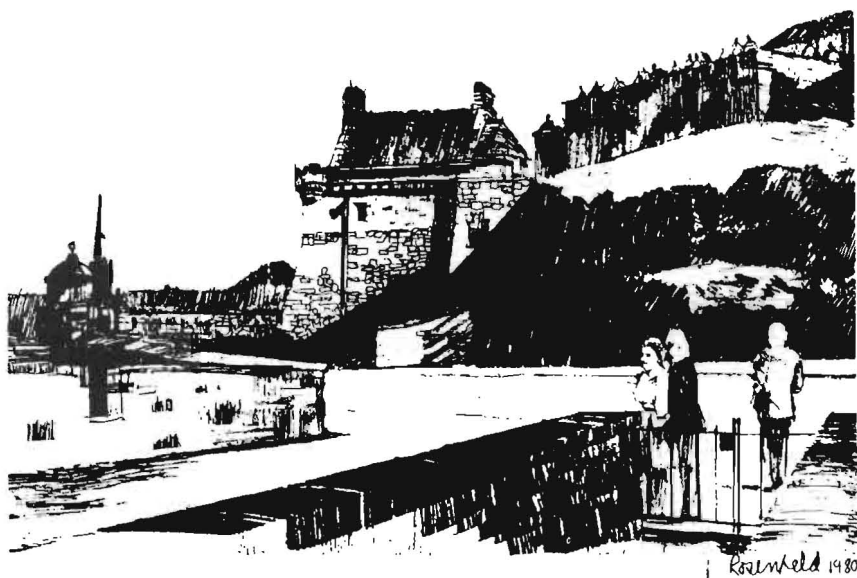

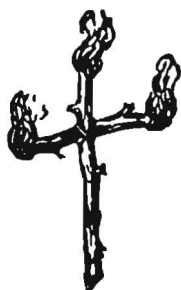


St. Margaret's Chapel, Edinburgh Castle

COUNCIL MEETING

October 17, 1980

The Council Meeting of the American Clan Gregor Society was called to order by the Chieftain, William E. McGregor, at 9:15 A.M. on October 17, 1980, in the Sheraton Center, Charlotte, NC. Twenty-six members were present, making a quorum. These included: William E. McGregor, Joseph C. Tichy, Jr., Mrs. Joseph C. Tichy, Jr., L. Burns Magruder, Jr., Mrs. William C. Stokoe, Jr., Dr. Mary Louise Rutledge, Cmdr. John G. Urquhart, the Rev. Horatio M. Richardson, William E. MacGregor, Jr., Dr. Charles G. Kurz, Douglas Neil Magruder, Dr. R. Gregory Magruder, John Murdoch MacGregor, Lt. Col. Robert W. Fuller III, Lt. Col. E. Phillips Grier, Sr., Mrs. Christopher Watson, Lt. Col. Mason M. Lummis, Dr. J. David Stratton, Dr. Russell C. McGregor, Mrs. William W. Richardson, Harry W. Blunt, Hon. Hugh B. Campbell, Gordon M. F. Stick, John W. Clagett, Mrs. Horatio M. Richardson, and Dr. William C. Stokoe, Jr. Two guests were present from Canada: Kenneth MacGregor and Robert MacGregor.

The meeting opened with a prayer led by our chaplain, the Rev. Richardson. Following this the minutes of the last council meeting were approved as printed in the Yearbook. The Scribe, Mrs. Stokoe, read two letters to the Society, one from the Prince Georges Heritage, Inc., thanking us for a contribution towards the restoration of the Archibald Magruder House and the other from Roderick A. MacGregor of New Glasgow, Nova Scotia, thanking the Society's representatives who honored his great-grandfather, the Rev. James Drummond MacGregor, by laying a wreath at the monument to his memory in Pictou, Nova Scotia, during their visit to that area in the summer of 1979.

The Chieftain then called for reports.

Our Treasurer, Cmdr. Urquhart, made his report. This included an announcement that a \$15,000 Certificate of Deposit has been purchased with monies from the savings accounts of the General Fund, the Marshall Magruder Library Fund and the Special Account. After discussion, a motion was made by Russell McGregor that the Council be given an overall statement listing the liabilities and assets in each account. This motion passed. A motion was then made by Mason Lummis that the Treasurer's report, which is printed elsewhere in these pages, be accepted with the provision that a statement of assets and liabilities be included to show the total worth of each fund. This motion was approved.

The Trustee's report was given by Judge Campbell. Mr. and Mrs. Joseph C. Tichy, Jr., have made a gift to the Charity and Education Fund of two parcels of land at Avon, NC, which carry an estimated value of \$6,000 and \$10,000. These will be sold and the proceeds will go to the C&E Fund. A motion was made and passed that the trustees be empowered to sell the lots. Judge Campbell also stated that the balance in the Fund was \$4,412.73, and he moved that all but \$1,000 of this be given to the Edward May Magruder Scholarship Fund. This motion passed.

Dr. R. Gregory Magruder then gave his report on the Edward May Magruder Scholarship Fund which had a balance of \$27,184.09 as of September 30, 1980. An award of \$2,000 has been made to David L. Hawkes, a third year medical student at the University of Virginia, for the 1980-81 session.

The Registrar, Mrs. Tichy, reported that there are thirty-seven new members, two reinstatements, four junior members, and that eight of the new members are attending the gathering.

Mrs. John E. Loveless, our Historian, being unable to attend the gathering this year because of ill health, her report was read by the Scribe. Ten births and eight marriages have been recorded this year and there were thirteen deaths of members and two of relatives of members.

Mrs. Horatio M. Richardson, our Editor for the 1980 Yearbook, expressed her pleasure at the opportunity offered to her of being the Yearbook editor and thanked the Society for their help. A round of applause was given for her work on the yearbook and she was thanked in turn.

The Librarian, Dr. Kurz, reported on the continued use of the Marshall Magruder Library by members. He particularly spoke of the contribution of Mrs. Blunt and Mrs. Tichy towards completion of the Yearbook index system.

Mr. Blunt then spoke of the necessity of finding a new home for the library now that the fees for use of the room in Heast Hall have increased. He suggested that a committee of Dr. Kurz and Mr. and Mrs. Tichy find a new location. He also made a motion authorizing payment of the contribution currently due for the library space. This motion passed.

The Assistant Chieftain, Mr. Tichy, reported that the Society has mailed out over 4,000 pieces of mail this year under its tax exempt status. The Directory was published and distributed. The Gathering next year will be at *Fort Magruder Motel* in Williamsburg, Virginia, on the site of old "Fort Magruder". The dates will be October 9 and 10, 1981. A motion was made that the 1982 gathering be held on the first weekend in October thus enabling us to meet at the Hotel Dupont in Wilmington, Delaware. This motion passed.

Mrs. Tichy reported that the dedication of a medium and low income housing complex in Montgomery County, named *Magruder's Discovery* after the title of the old Magruder estate on which it stands, was attended this past summer by the Tichys and the Stokoes. Dr. Stokoe was a speaker at the dedication. She also said that the Prince Georges County Historical Society has presented the American Clan Gregor Society with an award for service to the history of Prince Georges County (See p.).

Under Old Business, Dr. R. Gregory Magruder, Chairman, gave the report of the Committee for the Roll of Honor and Ceremonies for the Vietnam Veterans. That committee is made up of Lt. Col. E. Phillips Grier, Lt. Col. Mason M. Lummis, and Dr. and Mrs. R. Gregory Magruder. Dr. Magruder said that it had been decided to include non-military service personnel as well and that two books have been compiled: one for military service and the other for non-military. A service flag has been made by Mason Lummis and a certificate with names printed by Wayne Lummis will be given at the ceremony and these names will be printed in the Yearbook.

William E. MacGregor, Jr., reported that the gift for Malcolm MacGregor, Younger of MacGregor, on his coming of age was presented to him this past summer in Edinburgh by Lt. Col. Grier. It is a swagger stick with the Scots Guards crest in silver.

Dr. J. David Stratton, reported on the gathering which is going successfully, and the Chieftain read a City of Charlotte Proclamation regarding the Gathering. The text of this proclamation was as follows:

CITY OF CHARLOTTE, NORTH CAROLINA,
PROCLAMATION

WHEREAS, The American Clan Gregor Society is the oldest organized Scottish Clan in the United States with roots in Scotland; and

WHEREAS, The Clan will bring honor to Charlotte by having its 71st Annual Banquet in the Queen City; and

WHEREAS, Their Pipe Band will perform on October 18, in Marshall Park and the public is welcome to attend; and

WHEREAS, Our own William E. McGregor is the present Chieftain of the American Clan Gregor Society while Brigadier Sir Gregor MacGregor of MacGregor is the hereditary Chief;

NOW, THEREFORE, I, Eddie Knox, Mayor of Charlotte, do hereby proclaim October 16 - 18, 1980 as

AMERICAN CLAN GREGOR SOCIETY DAYS

in Charlotte, and extend them a hearty welcome and an enthusiastic "haste ye back".

The Chieftain also stated that the promised clan banner is still unfinished because of the difficulty in obtaining the necessary yardage of ancient MacGregor tartan in woolen cloth of sufficient weight. He read a letter from the Clan MacGregor Latino-americanos in Mexico about their gathering. A motion was made and passed that we express best wishes from our society to theirs.

Dr. Rutledge reported on the cookbook. It is ready to go to press and will be a spiral bound book of about 350 recipes, indexed and with a list of contributors. Pre-publication price will be \$6.25.

Under New Business, Mr. Tichy, the Assistant Chieftain, moved that our by-laws be amended to allow us to begin our fiscal year on October first. This motion passed.

The Chairman of the Nominating Committee, John Murdoch MacGregor, then gave the report of the committee, which was moved and adopted.

A motion was made and approved that we express our thanks to Mrs. Loveless, the outgoing Historian, for her many years of service to the Society. Another motion was passed to allow Miss Haden, the incoming Editor, to appoint an assistant editor.

The Chieftain appointed Mr. Tichy to continue as his Assistant Chieftain for the next year, and there being no further business the meeting was adjourned at 11:05 A.M.

GENERAL MEETING

October 18, 1980

The General Meeting of the American Clan Gregor Society was called to order by the Chieftain, William E. McGregor, at 9:45 A.M. on October 18, 1980, in the Salon D of the Sheraton Center, Charlotte, N.C. Following a prayer by the Chaplain the minutes of the Council meeting were read and approved. Mrs. Tichy gave the Registrar's report and introduced new members and members attending the gathering for the first time.

The Historian's report was read in her absence by the Scribe, Mrs. Stokoe, and the Chieftain commented with sorrow on the death of Lady Gylla.

The Chieftain announced that the gift of two parcels of land in Avon, N.C., valued at \$6,000 and \$10,000 respectively, from Mr. and Mrs. Tichy, Jr., is greatly appreciated. He then spoke of the Clan Gregor Society of Latino-americanos, now in its second year. He introduced two visitors from Canada, Kenneth MacGregor and Robert MacGregor, who are interested in organizing a Clan Gregor Society in Canada.

Dr. Rutledge gave her report on the progress of the cookbook. The background of the cover will be ancient MacGregor tartan with lettering in white. Christmas delivery cannot be promised, but she urged members to take advantage of the pre-publication price.

Burns Magruder presiding, immediately following the close of the general meeting, and the meeting closed with a standing vote of thanks to Mr. and Mrs. Tichy for their generous gift to the Charity and Education Fund. Adjournment took place at 10:20 A.M.

The Hon. Gylla Lady MacGregor
of MacGregor OBE

The Honourable Gylla Lady MacGregor of MacGregor OBE

The Hon. Gylla Constance Susan Rollo, born in London on 1 August 1899, was the youngest daughter of The Hon. Eric & Mrs. Rollo. She was educated privately and after training at Guys Hospital was in charge of the Plaster Dept. of Edmonton Special Military Hospital 1917-1919. She became private secretary to the Editor of the Morning Post in 1921, a post she held until she married Captain Sir Malcolm MacGregor of MacGregor, 5th Baronet and 22nd Chief of Clan Gregor in 1925.

The 1930s saw Lady MacGregor playing an increasingly important part in the development of Scotland as it came out of the depression. She was a member of the Scottish Development Council, the Council for Art and Industry, the Scottish Housing Advisory Committee and the Council of the National Trust for Scotland. She was Chairman of the National Exhibition of Needlework in Edinburgh in 1934 and a member of the Council of Management for the Empire Exhibition in Glasgow in 1938. She was a needlewoman of formidable ability in her own right.

With the advent of the 2nd World War, Lady MacGregor took additional responsibilities and in particular became Chairman of the Women's Land Army Committee for Perthshire. In 1947 she helped to organise the Enterprise Scotland exhibition and continued in the post-war years to play a part in Scottish Industry. She became a member of the Scottish Tourist Board and the Council of Industrial Design. She was Chairman of the Amenity Committees of both the North and South of Scotland Electricity Boards and a member of the Royal Fine Arts Commission for Scotland. She was awarded the OBE in 1948 and the Order of the Vasa 1st Class of Sweden in 1954.

She had a deep interest in architecture and archaeology, particularly of the classical period. An inveterate explorer, she had a great love of travel often managing to get herself, no doubt in great discomfort, to some of the most remote areas of the world such as Afghanistan and the High Andes in Peru.

She suffered a serious stroke in 1971 from which, in characteristic fashion, she made a remarkable recovery through sheer determination. Slowly her health began to fail and in recent years she turned her energies to her garden and home in Lochearnhead.

Gylla Lady MacGregor's outstanding quality which she retained to the end of her life was an all consuming interest in people and particularly the young. Her mind was alert and inquisitive and she had great zest. She died suddenly on 1st February 1980 aged 80 and will be sadly missed by her friends from so many different walks of life and professions.

The members of A.C.G.S. were charmed by Lady Gylla when she accompanied Sir Malcolm to our October 1952 Clan Gathering in Washington, D.C. Their visit was the occasion of an extended tour of the eastern part of the United States, visiting the homes of many Clan officers. Her article in the 1953 Year Book, pp. 19-23, recounts the rigors of that trip and the pleasure of meeting our Clan Society members.

Lady Gylla also attended our October 1962 Gathering in Richmond, Va., on which occasion she was made an Honorary Life Member and was the guest speaker at the banquet. (1963 Year Book, pp. 46-50)



Ella Magruder Braun

Born August 13, 1902 - Hillsboro, Oregon

Died December 13, 1979 - Portland, Oregon

Ella was the first child of James and Elzora Magruder. She was reared in Hillsboro by her grandmother, and was close to her father and her brother, Sam.

Because she suffered from severe asthma attacks throughout her childhood, she had several interruptions in her education. She persevered and graduated from high school in 1923, shortly before her 21st birthday. She continued her education at, what was then, Oregon Normal School in Monmouth. After graduation in 1925, she accepted a teaching position in Joseph, Oregon.

In 1927 she married Carl Braun. Two children were born to them, Jim and Carol.

She worked in clerical positions for many years, and when both children were grown, she courageously set out to build a new life for herself. In 1956, at the age of 54, she accepted the position of director of women's dormitories at Cortland State College in New York. Her association with the students brought a new enthusiasm to her life. She took advantage of the opportunities to travel each summer and saw first hand many of the countries that she had come to know through books.

She retired in 1974, returning to Portland to be near her family.

All of her life she had a great love for books, which may explain how it was that, although she aged physically, she remained mentally young.

Miller Reese Hutchison, Jr., died on February 2, 1980, at his home in Rochester, N.Y., aged 77 years.

For many years he was an engineer inventor with the Eastman Kodak Company in Rochester, and held many patents for his inventions. After his retirement, he spent six months of every year on Nantucket Island where he had a home at 47 Centre Street.

Mr. Hutchison was a member of the Presbyterian Church, the American Clan Gregor Society, the New England Genealogical Society, an Honorary member of the Nantucket Maria Mitchell Association and for some years the chairman of its Building and Preservation Committee, a member of the Nantucket Historical Society, and a long-time member of the Nantucket Yacht Club.

He leaves his wife, Marguerite Pinkney Hutchison, his son, Lewis Dwight Hutchison and five grandchildren: Miller Reese Hutchison III, Heather Reese Hutchison, Kimberly Hamilton Hutchison, Warren Chadwick Hutchison and Dwight Barton Hutchison.

Interment was on Nantucket Island, Mass.

Helen Muncaster Gassaway
(1896-1980)

Helen M. Gassaway was born December 9, 1896, in Montgomery County, Maryland, the daughter of John Hanson Gassaway and Helen Muncaster Gassaway (Clan No. 252), of Rockville, Maryland. She was graduated from Rockville Academy and Fort Loudoun Seminary, Winchester, Virginia, and in 1923 from the School of Nursing of the Church Home and Hospital in Baltimore, Maryland. In 1959, she received a B.S. degree from McCoy College of Johns Hopkins University.

After several years of private duty nursing, she returned to the Church Home and Hospital as a Supervisor, remaining there in various capacities and eventually serving as Assistant Director of Nursing Service until her retirement in 1961.

Helen was active in nursing organizations, holding offices in the Alumnae Association, the Maryland Nurses Association, and the Maryland League of Nursing. She was a member of Brown Memorial Presbyterian Church, Baltimore, Maryland, for over fifty years and was active in their women's organizations. A great lover of music, she participated in their musical programs, especially, singing in the choir. She worked with "Meals on Wheels" for 12 years and, for 15 years after her retirement, did volunteer work at the Church Home and Hospital. She was a member of the Maryland Historical Society, the English Speaking Union, and the American Clan Gregor Society (Clan No. 253).

In 1977 Helen moved to Asbury Village Apartments in Gaithersburg, Maryland, where she died of a heart ailment on May 29, 1980. A memorial service was held at Brown Memorial Presbyterian Church, June 2nd, and on June 5th, graveside services and burial took place at the Muncaster family lot at Oak Hill Cemetery, Georgetown, D.C., with the Clan Society Chaplain officiating, and a piper in attendance. She is survived only by cousins, many of whom are Clan Society members.

Helen was one of the most self-effacing, kind, gentle, patient and thoughtful persons any of us will ever meet in life. Yet, she had a determination and a sense of humor that helped her face life with great fortitude and courage. Her whole life could be summed up by the words - loving service to others.

Richard Robbins Kane

Richard Robbins Kane, aged 71, died at his home in Towson, Md. on December 20, 1979, of a heart attack. He was the son of Samuel Rankin Kane whose family lived on Kane's Road in the Long Green Valley, and the former Frances Bell Robbins. Richard Kane was a native of Baltimore and attended public schools and Boys' Latin School before moving to Atlanta, Ga., with his parents as a teenager.

He was a 1929 Phi Beta Kappa graduate of Davidson College in North Carolina. He first took a job with the Proctor and Gamble Company, but a few years later joined Coca-Cola USA and was assigned to the Baltimore area as a sales representative. He had been a marketing employee of the Coca-Cola Co. in Baltimore for more than 30 years before he retired in 1968.

He married Eleanora Livingston Bowling of Baltimore in 1938.

Mr. Kane was active in the Society for the Preservation of Maryland Antiquities, the local St. Andrew's Society, the national Order of Founders and Patriots, the American Clan Gregor Society, and was an officer of the Col. Nicholas Ruxton Moore Chapter of the Sons of the American Revolution. He was serving his third term as registrar of the SAR Chapter when he died. His principal hobby was stamp collecting, with United States and Vatican City stamps as specialties.

Besides his wife, he is survived by two brothers, Edward Robbins Kane of Atlanta, and John Robbins Kane of Newport News, Va.

Donalda MacGregor Knighten

Donalda H. MacGregor Knighten was born in Hood River, Oregon, on August 2, 1900, the daughter of Annie Laurie Currie and Alexander MacGregor. She was reared in Portland, Oregon, with three sisters Ruth Jean, Helen and Margaret, and two brothers, John Murdoch and Allister MacGregor. She attended Eastern Washington and Eastern Oregon Universities and Monmouth Normal School. She lived in Moro, Oregon, from 1931 until her death.

Mrs. Knighten and her late husband, Wily W. Knighten, were community leaders and highly respected educators in Oregon for many years. She was a member of the Oregon and National Education Associations, the National Retired Educators Association and a member of the education honorary, Delta Kappa Gamma. In 1965 she was awarded the Merit Award for Distinguished Education Services in Morrow County, Oregon, schools.

Mrs. Knighten was Unit Secretary, President, District President, and State Chaplain for the American Legion Auxilliary. She was a past Worthy High Priestess of the White Shrine of Jerusalem, past Worthy Matron of the Order of the Eastern Star, past president and past District President of the General Federation of Women's Clubs of Oregon, and a member of Maryhill Museum Society, Columbia River Maritime Museum, the Scottish American Heritage Society, and the American Clan Gregor Society which she had served many years as the State Deputy Chieftain for Oregon.

Mrs. Knighten's death on January 28, 1979, at the home of her daughter in Seattle, Washington, was reported in the 1980 Year Book. Funeral Services were held in Portland, Oregon, with burial in Willamette National Cemetery. She is survived by her daughter Anajean Knighten Miller of Seattle, her son Wily W. Knighten of Mustang, Okla., her sister Helen Lee of San Francisco, Calif., her brothers John Murdoch MacGregor of LaJolla, Calif., a former Chieftain of A.C.G.S., and Allister MacGregor of Bellevue, Washington, and three grandchildren, Laurie Ann Miller, and John Stuart Miller of Seattle, and Jodi Rene Knighten of Kenai, Alaska.

1899-1980

Ruth Jean MacGregor (Clan #1543) died suddenly and unexpectedly on March 20, 1980 in San Francisco while visiting her sister Helen MacGregor Lee (Clan #1567). She was buried in Portland, Oregon, where she had lived all her life.

She was born in Spokane, Washington the eldest daughter of Alexander and Annie (Currie) MacGregor.

At the University of Oregon she was an enthusiastic member of the womens varsity basketball team. Her sorority was Alpha Chi Omega, of which she was an active member all her adult life. She earned a degree in Business Administration, with credits in Education qualifying her for lifetime teaching certificates.

She taught school for a very short time. Her successful career, until retirement age, was as an accountant and auditor with the U.S. Army Corps of Engineers in the very busy Portland office.

All her life she was keenly interested in the outdoors. A member of the Mazama Club (Indian for mountain goat) she, with its members, climbed many of the perpetually snow clad mountains of the far west. She also belonged to the Eastern Star (a masonic group), wherein she held offices.

Her chief contribution to the Clan, of which she was a dedicated member, was her conscientious service as a charming hostess for her brother John when he was our Chieftain.

She is survived by brothers John and Allister, sister Helen and a number of nephews and nieces. Two of her sisters had died only months before Ruth: Margaret MacGregor (Clan #1544) and Donalda MacGregor Knighten (Clan #1513).

Ruth had a calm and persistent way of being loyal to family, clansmen, friends and associates.

Denton A. Magruder

Professor Denton A. (Mac) Magruder, Professor of Business Administration and Accounting at Antioch College, Yellow Springs, Ohio, from 1922 to 1957, died on March 2, 1980, at the age of 87 years. Professor Magruder served for some years as head of the Business Administration Department and also served as Business Manager in the early fifties. He was a member or chair of various committees and was active in Antioch community life. He was active as well in the Yellow Spring community, having served as school board member, Miami Deposit Bank board member, and co-founder of Community Chest. He was instrumental in the drive to build the Yellow Springs public library building (now the school board building). Professor Magruder's distinguished service to the College and the larger community is remembered with deep appreciation.

After retirement and until 1973, Professor Magruder provided a tax and consulting service. He was a resident of Yellow Springs until his death. He is survived by his wife Hester, his daughter, Mrs. Mary Van Wart, and his grandson, Jan Van Wart.

William H. Magruder

William Henry Magruder, a former resident of Palo Alto and Los Altos, Calif., who retired and moved to Sunriver, Oregon, died there on October 20, 1979 of a brain tumor.

Mr. Magruder graduated from Harvard University in 1940 and during WW II served in the U.S. Army Field Artillery. He received the Air Medal for Meritorious Service as a liaison pilot in Europe.

During the twenty years when he had lived in Palo Alto and Los Altos, he was associated with several investment houses and was vice president and branch manager of the Palo Alto office of Blyth-Eastman Dillon.

He had served the community on the Los Altos Hills Planning Commission, and the Stanford Peace Program from 1961-1964. He was a member of Kiwanis Club, Elks Lodge, the Stock and Bond Club, and was a Mason, and a member of ACGS.

He is survived by his wife, Florence, of Sunriver; a son, Paul, who is a student at the University of California at Berkeley; his mother, Martha Magruder, and a sister, Jane White, of San Jose, Calif.



Donald Henry McLellan

Donald Henry McLellan, the son of Robert Fletcher McLellan and Louise Mai Gregorie, was born on November 23, 1913 in Sumter, S.C.

Mr. McLellan was the Assistant Postmaster at Sumter at the time of his retirement on December 27, 1968 after 33 years 5 months of Government Service. He had been with the Post Office Department for 31 years. He had served overseas with the Army in England and France for 2 years, 5 months.

He was a life member of the Claremont Masonic Lodge; the American Legion, Veterans of Foreign Wars and the American Clan Gregor Society; a member of Sumter Geneology Society, South Carolina Historical Society, Huguenot Society of S.C., Sons of Confederate Veterans, and the Ronald McDonald Clan (U.S.A.). He was an Episcopalian.

Mr. McLellan died on December 27, 1979, and was buried in Sumter Cemetery. He is survived by his wife Agnes Burgess McLellan; one son, Donald Henry, Jr.; three grandchildren, Donald III, Collin Louise, and Gregorie Seabrook McLellan; two sisters, Mr. Louise Israel of Oshkosh, Wis., and Mrs. Matilda Diemer of Spring City, Pa.; and a brother, R. F. McLellan, Jr.



C. Caruthers Sullivan

C. Caruthers Sullivan died unexpectedly on October 14, 1979, at his home in Hattiesburg, Miss. He was 78.

Born in Como, Miss., he grew up on the Millsaps College campus in Jackson, Miss. He completed his junior year in college at Millsaps and graduated from Emory University in Atlanta, Ga., with a major in chemistry.

He joined Standard Oil of Kentucky (now Chevron USA) in its Jackson District office on February 1, 1923, and was appointed commission agent for Hattiesburg and surrounding area effective July 1, 1939. After 56 years of continuous service with Chevron, he retired in August 1979. He had held many offices and served on several national committees in the oil industry, including the American Petroleum Institute and National Oil Jobbers Council. He was past president of the Mississippi Oil Marketers Association.

A reserve officer at the outset of World War II, Mr. Sullivan went on active duty as a Captain in the Chemical Corps. He retired as a Lieutenant Colonel.

Mr. Sullivan was prominent in church and civic affairs throughout his years in Hattiesburg. He was a Rotarian, Mason, Shriner, and Elk, a member of the Main Street Methodist Church and past chairman of its Board, and a director of the Millsaps College Advisory Board. He served as chairman of the Education Committee of the Mississippi Economic Council, president of the Mississippi Department, Reserve Officers Association of the U.S., and a director of the Mississippi Historical Society. He was for a number of years a member of the National Council of United Service Organizations, was on the supreme executive committee of Kappa Sigma International Fraternity, and had received the Outstanding Citizenship Award given by the Interfraternity Council at the University of Southern Mississippi.

He is survived by his wife Norma Williams Sullivan, and two sons, C. Caruthers Sullivan, Jr., and Garland W. Sullivan, all of Hattiesburg; two sisters, Mrs. Lawrence Corbin of Ocean Springs and Mrs. Garland Williams of Memphis; six grandchildren and four great-grandchildren.

REMARKS AT THE CEREMONIES FOR THE VIETNAM WAR VETERANS

It was October 21, 1805, minutes before the great naval battle of Trafalgar. The signal to the British fleet from the Commanding Officer, Vice Admiral Horatio Nelson, was as follows: "England expects every man to do his duty". Someone has said that Admiral Nelson did not mention Scotland, because he knew the Scots would do their duty. How true. One has but to glance through the pages of history to become aware of the distinctive devotion to duty of those kilted mountaineers, who inhabited the heather-clad mountains of the Lion of the North. This distinguishing quality along with loyalty, valor and sacrifice, which are marks of a soldier, sailor, and flyer have been most evident in their descendants wherever they may be. We in the United States are cognizant of the important part those of Scottish ancestry have played in the military annals of our country.

Three times, after World Wars I and II and the Korean War, the members of the American Clan Gregor Society paid tribute and honored their members and other kin, who served in our armed forces during those conflicts. So, here tonight, the members of this honorable society extend a heart warming welcome to you, and wish to honor you members of the Society and others of your family, who served in the military forces of the United States during the Vietnam War. When your country called, you answered the call to duty to fight in a little known, primitive, foreign country half way around the world. By so doing, you gave support to the goal of human liberty and the cause of freedom in the finest tradition of your Scottish ancestors. Through circumstances beyond your control, and in spite of your valor, loyalty, sacrifices and suffering, final victory was denied.

As tangible evidence of the highest regard in which you are held, the Society has ordered a Roll of Honor of those who served, to be compiled and filed in the Archives of the Society; and, a service flag to be made on which each veteran is represented by a star. It is displayed on the wall this evening, along with the other three flags. Also, a special certificate is to be presented to each veteran.

There are 35 veterans to be so honored. A number of you have very distinguished military records. But, time does not permit relating these in detail. However, there are several I should like to mention. First, there is one young woman on the Honor Roll, Karen Ann Newberry. Another veteran known to many members of this Society is Thomas Mitchell McNish, Air Force flyer. More will be heard of Lt. Col. McNish later this evening. Lastly, there are three brothers, the grandsons of Brig. Gen. Marshall Magruder, former Chieftain of this Society. Their names are Robert Bruce, Peyton Marshall, and Douglas Graham Magruder. Two of them graduated from West Point and one from the Naval Academy. Even though his two brothers were already in Vietnam, Douglas Graham Magruder, assigned to the 82nd Airborne Division, volunteered for duty in Vietnam. On November 18, 1967, while in the combat zone and assigned as forward observer for an artillery unit, he was killed. First Lt. Magruder is represented on the service flag by the gold star. He performed his duty. In so doing, he made the supreme sacrifice for America.

INTRODUCTORY REMARKS ON LT COL. THOMAS M. McNISH

It is very appropriate that tonight we have a distinguished young man with us. While he is known personally to many of us, there are others who, for years have known of him by name only. In 1965, when a young air force pilot, he attended the Grandfather Mountain Highland Games with his father. He demonstrated his athletic ability by winning the tossing of the sheaf contest, and making a new record. Many here are aware that this is the contest established and sponsored by our Society. Mr. James Kier, beloved member of this Society and now deceased, in presenting the trophy to this young man said, "this is probably the first and last time a MacGregor will present this trophy to a MacGregor". A spark was apparently ignited. He met other members of our Society, including the Leckys that day. Friendships developed.

What else do we know about this young flyer? He was born in Nashville, Tenn., and grew up in the small town of Franklin, in the mountains of western North Carolina, from whence came many of those frontiersman of Scottish descent, who defeated the British at the Battle of King's Mountain in October 1780. From his record, that I summarize, it will be seen that his spirit is imbued with the unconquerable qualities of those mountain men of two hundred years ago.

After one year in the engineering school at North Carolina State, having decided on a career as an air force pilot, he entered the Air Force Academy in 1960. He graduated with an engineering degree in 1964, and went directly for pilot training at Phoenix, Arizona. He graduated in 1965 with the honor of being No. 1 in flying training. From there he was sent to Las Vegas for training in the F 105 plane, finishing in May 1966. He was then ordered to Thailand for combat duty in the Vietnam War. On September 4, 1966, while flying his forty-fifth combat mission, his plane was shot down near Hanoi, and he was taken prisoner. There followed years of waiting, discouragement, boredom, anxiety, and torture. Many would have succumbed mentally or physically, but he "never gave up". It was during that time he vowed that if he ever got out of North Vietnam alive, he would spend the rest of his days helping other people.

When members of this Society learned that he was a prisoner of war, there was anxiety and concern for his safety and well being. There was nothing our members could physically do to gain his release. However, many remembered him in their prayers, and letters of sympathy were sent to his mother, his father having died. Betty Lecky through correspondence with Mrs. McNish, kept the Society informed of any news she had of him. At the annual Gatherings, prayers were offered for him.

Finally, on March 4, 1973, after 6½ years of being a prisoner of war, he was released and flown back with others to the United States. When the plane landed, television cameras were on hand. He was recognized by some viewing the event. Long distance calls to the Harry Blunts announced that Tom McNish was back home. There was joy and thankfulness.

His roster of decorations are many, including a distinguished flying cross, a legion of merit, 3 silver stars, 3 bronze stars, and 2 purple hearts.

After repatriation, he again attended the Highland Games with his mother. There he met more members of our Society. His presence brought joy to their hearts.

But, this young man had more to accomplish. Having decided on a career to relieve human suffering and save lives, he entered the medical school at Emory University from which he graduated in 1978. He is completing the family practice program at the University of Texas Health Center in San Antonio, where he is chief resident.

Lt. Colonel McNish and Mrs. Yona Gross Dale were married in August 1973. She was the widow of a Korean war veteran, and had two children. The McNishes, also have a young son of their own.

Finally, let me say for a man to live through the rigors, dangers, suffering, and sacrifices endured by him, there must have been some source of outside strength to sustain him. Either, he carried the left hind foot of a graveyard rabbit in his pocket, or, the Supreme Sky Pilot, who watches over all of us, has been flying a protective cover over him, because this man has been chosen, and is destined to fly many more combat missions in his newly chosen field of medicine. I believe it is the latter. It is my great pleasure to present to you a very patriotic and most outstanding American, Lt. Colonel Thomas M. McNish, United States Air Force, senior pilot and flight surgeon. He is also an illustrious member of this Society.

ADDRESS MADE BY LT. COL. THOMAS M. McNISH

Chieftain McGregor, Mrs. McGregor, honored guests and fellow Clansmen:

I am humbled by being asked to talk to you tonight. When I was first asked, I accepted immediately because I had some things I wanted to say to this Society. Things of a personal nature, so I'll get those out of the way first and then try to give you other thoughts that you will want to hear.

First of all, on behalf of those of us you have recongized tonight by adding us to the Honor Roll, we are extremely appreciative of this recognition. We're proud to have served our country. We did it willingly and, even though it was in an often unpopular war, we wanted to defend our country. We wanted to do our duty and so this honor is just an added token from our country for which we are grateful. As we've heard tonight, it's been in the tradition of the McGregors to serve when called upon.

On behalf of that group of us who were held prisoners of war (myself in particular), I want to thank all of you who wrote letters, who wore bracelets and particularly those who prayed for our return.

It was our trust that Americans and America in general would not forget us...would not desert us...that gave us the ability to endure the seemingly endless days, months and years that we were there. We, the returned POW's, are *all* grateful to you and to our government for bringing us *home with honor*. On a sadder note, on behalf of the 50,000 or more Americans who came back from Vietnam either in a box or not at all (unfortunately that now includes several MIA's who have been relegated to the position of "presumptive finding of death," a merciless way to tell their families that we gave up) I want to emphasize that, even though they'll never be back to enjoy this country, the things for which we fought and the things which we all love, and even though they gave their lives in what was really a losing war, we must try to make sure that their sacrifice will never be allowed to be meaningless.

In my own behalf, I want to thank all the members of the Clan who remembered me in their prayers. Particularly I want to thank the Leckey's who were so close to my family and kept my mom aware of what the Clan was doing and of their prayers for me. I can't tell you how much it touched me to hear, when I got home, what my mom had to say about how you all had continued to think of me and pray for my return. Unfortunately, my mom only lived for a year after I got home, but she was able to attend the Grandfather Mountain Game with me in 1973. That's one of the bright spots of my memories after I got home.

Since I came home, everything's really come up roses. It's kind of hard to add to what Dr. Magruder has said in his introduction, but the most significant event since I got home was that I married a wonderful woman with two daughters and we now have a son who is 4½.

Those are the things I wanted to have the opportunity to say to you but now I'm faced with the question of what I can say that will be of use and of interest to you. I won't go into detail about what happened to the POW's in Vietnam. That's available in several very well written books. One thing I do have, which I hope will be of interest to you, is a view of the only war that our country ever lost from the perspective of one who had daily contact with the enemy during that war. I say that we lost because I think that the only

long-term victory we brought from Vietnam was bringing our POW's *home with honor*. If you look at the rest of the picture, I think it all comes up on the "defeat" side. I believe the most important thing for us to look at is "what can we learn from our defeat?" They say that we learn from our mistakes...then we should be much wiser after Vietnam. That war has undoubtedly changed our country. It's changed the way we, as Americans, look at things and it has particularly changed the way our young people think. For several years after the war, it changed, dramatically, the way that young people responded to signs of patriotism, like the American flag and the playing of the Star Spangled Banner. But, then again, I see signs of hope, now, in the young people...it seems that they are coming back to a more patriotic stand. An example of the way that this has affected our country is reflected in something my dad used to tell me. When I was young he used to say to me, that, "America is the greatest country in the world. We have won every war we've ever fought." Then came the Korean conflict and he had to modify that statement just a little bit. He'd say, "Son, we're the greatest country in the world and we've never lost a war." Now, I'm faced with the question of what to tell my children? I think that the proper answer is that we are still, by far, the greatest country in the world, but we lost one and we're going to have to learn from our mistakes.

I have no doubt that we should have been in Vietnam, I do have some serious qualms about the way the war was conducted. I think that the fact that we belonged there has been adequately borne out recently. The "Domino Theory" has been proven. All you have to do is take a look at Southeast Asia right now and no one could argue with that.

During my time as a prisoner, I came to understand what an ominous threat to our country Communism really is, but it took years of daily exposure to the Communist way of thinking to understand how they think. We, as Americans, can't understand because we've been taught that there is a right and there is a wrong. We've been taught that there is an absolute truth and, there is falsehood. To us those are clear, but, to the Communist, right and wrong vary according to what the government tells them to believe. As Ho Chi Minh stated, "Truth is that which serves the State." We saw that very clearly in our daily life over there because one day they'd treat us like criminals and the next day they'd come back and say that we were merely victims of our cruel government. They could tell us one thing one day and another the next and they saw no difficulty with that at all. "Truth" just changed from day to day. It took me years to understand that, even being with them every day. If there is some way that I can help other Americans understand that we can't try to predict or understand Communism in the framework of our moral standards, then my experience will have served some purpose.

Here at home, during the Vietnam war, you heard lots of anti-war demonstrations, anti-government protests, draft dodgers, etc. In fact, sometimes it seemed (if you were to believe the media reports) that there were more draft dodgers than volunteers, more flag-burners than flag-wavers. In prison, we heard about at least as many of those as you did, without hearing any of the other side. The enemy took great comfort from all this and hoped that it would depress us to the point that we would begin denouncing our own government. In fact, the main reason for torturing us was to get us to write "war crime confessions", anti-war statements, anti-government statements and,

amusingly enough, many of us were tortured to write statements saying that we were being well treated! Most of us dealt with the anti-war demonstrations by feeling that, even though we didn't agree with them, and, even though we believed that they were prolonging the war, and therefore our imprisonment, they were, indeed, an expression of the freedoms for which we were fighting. That rationalization broke down, however, with individuals like Ramsey Clark and Jane Fonda who gave tremendous aid and comfort to the enemy. I still can't excuse a wealthy actress who goes to the enemy's country, publicly condemns her own government, refers to those of us fighting the war as "criminals" and, in radio broadcasts to the soldiers in South Vietnam, encourages them to turn their weapons on their own officers. This, to me, is still treason!

We were continually frustrated by the fact that the politicians controlling the war insisted on tying one hand behind our backs and on telling the enemy everything we were going to do before we did it. Nothing depressed me more during my time in prison than the period following the bombing halt just before the 1968 elections. Similarly, nothing raised our spirits more than the resumption of the massive bombing raids on Hanoi and Haiphong in the summer of 1972. We knew that this was what would be needed to get us home with honor.

In summary then, these are the things I feel that we should have learned from our defeat:

1. Communism is, indeed, a malignant presence on our planet and must be contained.

2. We must protect and cherish our freedoms, but, we should be less lenient with those who abuse them.

3. We must never again commit our country to war without the American people's support.

4. This defeat must not become a precedent in our national or personal policies, for, as General MacArthur said, "There is no substitute for victory."

5. Finally, and most important, we must never again commit American soldiers to battle without committing ourselves as a country to *victory*.



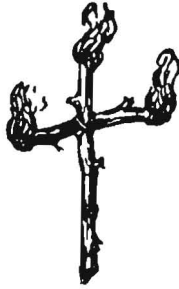

THE 21st BIRTHDAY CELEBRATIONS FOR MALCOLM MACGREGOR YR OF MACGREGOR IN 1980.

As most of you will know Malcolm was born on 23rd March 1959, so his 21st birthday fell this year and we felt we should celebrate it suitably. We planned therefore, in accordance with his military duties to hold two parties during the year. One, a family dinner on the day of the birthday, and secondly a dance in August to be held both for Malcolm and his brother Ninian. Unfortunately, a few weeks before the first party, Malcolm's dearly loved grandmother Gylla, Lady MacGregor died, and I know many of you will have read her obituary in this Year Book.

Knowing however, that she would not have wished in any way for the birthday celebrations to be curtailed because of this unhappy event, we went ahead as planned. Malcolm was duly released from Sandhurst for the weekend, and arrived at our house in Edinburgh with some of his military contemporaries. Almost equally unlucky at this time of the year was the weather. We suffered strong blizzards throughout the British Isles during that period, so my mother did not feel strong enough to accompany Malcolm's uncle and aunt to Scotland. Sadly, his paternal aunt, Mrs. Ellis, was also unable to be present. However, we managed to assemble a fair number of friends and close relations despite the inclement weather. The dinner was traditionally Scottish with the dishes mostly chosen by Malcolm, and abetted by my loyal staff I managed to accede to all his wishes, and I think everyone seated at the long dining room table enjoyed themselves. At the end of dinner, my brother, Malcolm's uncle & godfather, proposed his health, and was responded to by Malcolm in a touching and charming way. To end the ceremonial part of the evening, we had a selection of pipe music performed by Pipe Major MacDonald of the Scots Guards.

After we had recovered from this celebration, my husband and I realised that we would have to start to concentrate on the far larger task of arranging the dance for which we had already booked the venue, so in April my faithful secretary, Jenifer Skelsey, took the road from London for the first time, and we set about the writing of a large number of invitations. This task completed we awaited the replies, and hoped that a few people would turn up!

Eventually, the great day dawned, and where we had been unlucky with the earlier party, now we were blessed with a marvellous day & evening, which did not mean that the guests arriving in the kilts and evening dresses would be soaking wet before the party started. We were also lucky in being able to invite Lt. Colonel & Mrs. E. P. Grier (A.C.G.S. members) who have a home in Banffshire, Scotland. He presented the gift so graciously sent to Malcolm by your Society. This he did with some very well chosen words, and Malcolm responded. We then dined before setting off for the dance, which was held in the Officers Mess at Craigie Hall Military Headquarters, just outside Edinburgh. The Mess had been floodlit for us, and really looked most imposing with its arrangements of flowers on the steps leading up to it. Inside, the flowers were equally good, my florist having done an excellent job with the decoration. The main ornament was just above the band: two long swags of MacGregor tartan ribbon (kindly given me by Mrs. Ellice McDonald, Jnr), with carnations arranged on their bows.

To carry through with the MacGregor theme, the two boys and their father were all dressed in red and black MacGregor tartan and I hoped to complement them by wearing a dress of similar colours. Our labrador dog Spey (now deceased) wore a MacGregor tartan bow in red and green. He spent an excellent evening in the kitchens! As with most Scottish Balls we chose the traditional arrangement of having Scottish Country dances interspersed with ballroom dances, and this has the effect of giving everyone time to find their partner for the next reel, during the ballroom dances. About 275 people attended, and among Malcolm and Ninian's relations present were their cousins Dorothea, Countess of Mansfield, with her son-in-law and daughter the Hon. Malcolm and Lady Mariota Napier, Lord and Lady Rollo, and my Uncle from Cheltenham, England, who I feel will not see 70 again! A good time was had we felt by all, and in the Scottish dawn we finally said good-bye to the last of our guests, and feet somewhat aching took ourselves back to our beds. We had incidentally, been so inundated with Malcolm's and Ninian's friends, that we had to take a special apartment in Edinburgh for most of them to spend the weekend in.

BILL STOKOE — ONE FOR THE BOOKS

A special book on sign language, written in honor of Dr. William C. Stokoe, Jr., professor of linguistics and director of the Linguistics Research Laboratory at Gallaudet, was presented during the Centennial Convention of the National Association of the Deaf.

The book, *Sign Language and the Deaf Community: Essays in Honor of William C. Stokoe*, was edited by Charlotte Baker and Robbin Battison and was published by the NAD.

Work on the book began July, 1979, when the editors sent letters to 15 individuals, asking them to contribute to a book in honor of Stokoe. Each contributor has worked with Stokoe or has been influenced by his work.

The volume begins with an article about Stokoe's life by his wife, Ruth. Other articles discuss the structure of sign language, the deaf community, changes in the use of sign language in society, and sign language in other countries.

All proceeds from the book will go to the William C. Stokoe Scholarship Fund to continue the work Stokoe began almost 25 years ago. The fund will support students who have a major interest in research on sign language.

In the foreword to the book, Mervin Garretson, special assistant to the president at Gallaudet and a former president of the NAD concludes, "The work of Bill Stokoe has permeated all corners of the linguistic world. But more than that, it has created a renaissance among deaf persons everywhere. It has caused a rebirth of hope, pride, and confidence in ourselves as we take a more active role in the modern world. With every passing year, we will understand and appreciate even more the many contributions of William C. Stokoe, Jr."

COLONEL ZADOK MAGRUDER

Zadok Magruder was born in 1729 at "Dunblane," his father's plantation in Prince Georges County, Maryland. In 1751, he inherited from his father, John, 600 acres near Norbeck, Md. Here he built a fine brick house known as "The Ridge." In 1754, he married Rachel Pottinger Bowie.

Zadok was an ardent worker for the cause of resistance to England. His name appears on most of the Revolutionary Committees. He, like his brother Nathan, was chosen a member of the Commission to set up the new Montgomery County in 1776.

Zadok probably died on April 12, 1811, Easter Sunday. Rachel (Pottinger) Bowie Magruder predeceased him in 1807.

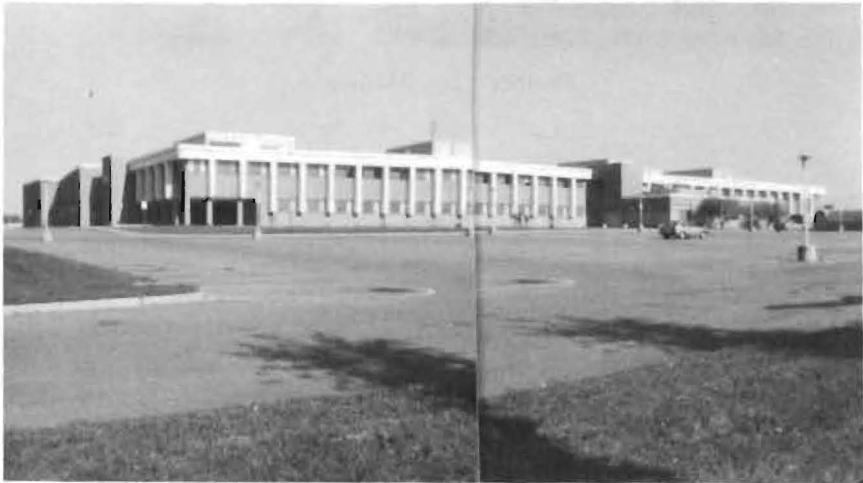
It is fitting that the School Board has named a school in his honor, the Colonel Zadok Magruder High School. Not only was he a civic leader, but he was a Colonel in the local Militia.

Colonel Zadok Magruder High School is located on Muncaster Mill Road in Rockville (Montgomery County), Maryland.

THE HOUSE THAT ZADOK BUILT

The following description of "The Ridge" was found in the Year Books for 1914 and 1957, and is re-printed here because it adds to the series on old Magruder homes.

"Colonel Zadok Magruder (1729-1811) was a youth of 21 years when he inherited his father's Piedmont holdings along with two negro men named York and Hercules.

"Zadok, who fought in the French and Indian War and distinguished himself as a Colonel in the Revolution, and as a leader in the early affairs of Maryland, was obviously a man of parts and it is not difficult to imagine him pushing York and Hercules to the utmost to get the house completed and "The Ridge" and his other lands into production to receive his bride, Rachel Bowie, nee Pottinger, whom he married in 1754.

"The dwelling the young people were the first to occupy was not a pretentious mansion, but it was substantially built of hand made English style brick molded from local clay. Its main rooms, with an almost unconscious elegance from the simple colonial woodwork, were spacious and designed for generous living. . . . In the "great room", as the living room was called in those earlier days, the broad fireplace was flanked by a handsome and ample wine closet.

"The house ("The Ridge") is one story, but it is large, and has a large cellar below. Four steps up to a square portico, with two round columns and side benches, find one at a large front door with glass side-lights and circular transom, opening directly into a parlor about twenty-five feet square. There is a small room back of the parlor, and a back hall with a winding stair six or seven feet wide, leading to four small bed-rooms up-stairs, with the usual sloping ceilings and dormer windows. The dining-room is to the right of the parlor, and the "mistress's" room adjoins it and the back hall. All had great fireplaces, where a four-foot stick was easily accommodated, but in early days there was no provision for warmth up-stairs at all.

"The kitchen is of stone, connected with the house by a long passage. It has a stone floor, eight-foot fireplace, and one small long window. The windows in the main building are large, with many small panes. All the old out-buildings—meat house, dairy, quarters, and barn—were of logs, and are still standing (1914), except the quarters."

HOME OF GEORGE FRAZIER MAGRUDER

The Old Chiswell Place on Cat Tail Road in the outskirts of Poolesville, Md., once the property of George Frazier Magruder, was restored by the Historic Medley District, Inc. (a group of preservationists), and offered for sale in 1978, in its 200th year. Only 6.75 acres were left from the once large working farm, but there were several surviving dependencies. These included a small stone spring-house, a log meathouse, and a small log barn or shed.

George Frazier Magruder moved his family in 1778 from Prince Georges County to a newly erected frame dwelling on 610 acres he had purchased in Montgomery County, Md. In 1803, the house was described as "a frame dwelling house 28 X 24 feet, with three rooms on the lower floor and two on the upper, a kitchen adjoining the house, and all necessary outhouses." The woodwork and hardware of the house were very refined, showing that it was built for a person of good taste.

In 1804, the place was sold to Col. Thomas Fletchall whose daughter Sarah (Mrs. William Chiswell) inherited it. William Chiswell was a planter, attorney, and county surveyor, and it was he who built the imposing 2-story Federal section of brick which became the main block of the house.

THE ANTE-BELLUM HOMES OF THE MAGRUDERS (An Up-date Report)

The Fielder Magruder home, "Mount Hope", in Cheverley, Md., which was first brought to our attention in the 1977 Yearbook, has been placed on the National Register of Historic Sites. This, however, does not prevent its destruction. The town of Cheverley had hoped to buy it, restore it, and use it as a civic center, but the funds were not available and the property is for sale. The concern is, of course, that a developer will buy the property and raze the house. Since it is on the National Register of Historic Sites, matching federal funds are available to a private buyer toward its restoration. The value of the property has been estimated at about \$90,000. It is one of the few Magruder homes still standing in this area and we would certainly regret its destruction. (See photo, p. 63, 1977 Year Book)

* * * *

One other old Magruder home in Prince Georges County, that of Dr. Archibald Magruder in Bladensburg, is listed in the National Register of Historic Sites. It is the only 18th-century stone gambrel-roofed house still standing in Prince Georges County. This house was built about 1742 and was used as a hospital during the War of 1812. Dr. Magruder lived there from the time of his marriage in 1844 until his death in 1863. Recognizing the architectural and historical significance of the house and the urgency for its preservation, the State of Maryland which owned the house conveyed it, in March 1979, to Prince Georges Heritage, Inc., an arm of the Maryland Historic Trust. They plan to restore the house and have acquired the assistance of the architect who restored the "Surratt House."

Happily, the Samuel Wade Magruder home, "Locust Grove" in Montgomery County, has been purchased by Chevy Chase Savings and Loan and is being restored to be used as offices and a small museum.

AWARD PRESENTED TO ACGS

For the past six years, on St. George's Day, the Prince Georges County Historical Society has commemorated the founding of the county and made awards to individuals and organizations that have contributed to the preservation of the historical and cultural heritage of the county.

This year, the dinner on April 23d marked the 284th anniversary of the founding of Prince Georges County. The American Clan Gregor Society was honored to be one of seven recipients of an award. We were cited for the historical and genealogical material in our Year Book, the resources available in our Library, and for the commemorative markers we have placed on many historical sites in the county. In addition, many individual members mentioned to us the efforts made by some of our early members to find and preserve early records of the county, and one even suggested that if it were not for ACGS there well might not be a Prince Georges County Historical Society.

The Assistant Chieftain, Joseph C. Tichy, accepted the award on behalf of the Society. Other members of ACGS in attendance besides Mr. & Mrs. Tichy were Dr. Charles Kurz, Mrs. Nancy Markanich and Mr. Frederick S. De Marr, who is the President of the Prince Georges County Historical Society.

Potter of Lynchburg, VA—Clan #1840) who was the MacGregor runner in the "Under 12" category of the Kilted Mile.

Sunday morning's outdoor church service was followed by the Kirkin' o' the Tartan and the Dedication of the CAIRN which is made up of stones representing more than 50 clans and societies, including our American Clan Gregor Society.

MEMORIAL CAIRN

A memorial cairn commemorating the 25th anniversary of the Grandfather Mountain Highland Games was dedicated July 13, 1980.

The cairn, traditional Scottish marker of special events from burials to battles, bears four panels, three of which now contain stones of 55 Scottish clans, families and societies. The stones came from locales of historic importance to their sponsors.

At consecration and dedication ceremonies on Sunday, July 13, at MacRae Meadows, the Rev. James A. M. Hanna, minister, Oak Hill and Horeb United Presbyterian Church, Oak Hill, Jackson County, Ohio, Cairn Committee chairman, said that "in medieval Scotland it was the practice when passing the burial place of a loved one . . . to place a stone on this grave and ask a prayer for the repose of the soul . . . 'Cuiridh mi clach 'nad Charn' (I shall add a stone to your Cairn)". He cited the cairns marking the Culloden Battlefield and the Bruce cairn in Galloway as notable examples.

Robert W. Groves, Jr., president of the Games, accepted it.

The cairn was designed by Douglas James Ferguson, artist-owner of Pigeon Forge Pottery.
