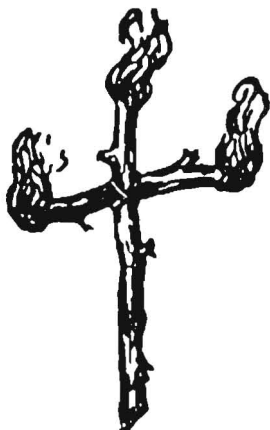

AMERICAN CLAN GREGOR SOCIETY, INC. COUNCIL MEETING — OCTOBER 13th, 2001

Chieftain Jeffrey McGregor called the meeting to order on October 13th, 2001 at 8:30am. Chieftain Jeffrey McGregor welcomed everyone to the 92nd gathering of The American Clan Gregor Society. He brought greetings from Scotland Sir Gregor MacGregor, who wished us a successful gathering and a safe return to our homes at the conclusion of our Gathering.

Rev. William McGregor gave the invocation.

Chieftain McGregor welcomed and introduced four new Council Members as follows:
Muriel King from Denton, Texas - who was unable to attend our Gathering
Nolan Sanders from Russellville, KY
Donald A. Gregg from McHenry, IL
Randal Zimmerman from Pensacola, FL

A card was circulated to be sent to Barbara MacGregor who is recovering from surgery.

The meeting continued with the reading of the Minutes of the Oct. 13th 2000 Council meeting. A motion was made to accept the minutes as read by the Scribe and was seconded. At this point our Assistant Chieftain suggested the possibility of an omission in the minutes and after some discussion a motion was made to amend the minutes, as previously read and seconded. The intention of past Chieftain, Malcolm MacGregor to support the CGS in the preservation and restoration of artifacts in Scotland was clearly stated in the minutes of the year 2000 Council Meeting but there was no similar motion made at the General Meeting. The Scribe offered to play the recorded tapes for verification. Our new Chancellor, Diana Browne was asked for her opinion and she concurred that the motion passed at the year 2000 Council Meeting should stand. Joe Tichy then suggested that if it is illegal to make an insertion, the matter could be handled later under 'Unfinished Business'. At this point Jeffrey asked the 'seconder' if he wished to rescind his 'second' to the motion to amend the minutes; this was done. The motion was then withdrawn. A new motion to accept the minutes of the year 2000 Council Meeting was made, seconded and passed.

The Treasurer, Robert (Sandy) MacGregor, distributed copies of his report and summarized the report for the Council. A motion was made and carried to accept the Treasurer's report as presented.

The Registrar's report was next on the agenda; however our registrar Millie Gregg is ill and unable to attend the Gathering. Tess James gave The Registrar's report; she reported for Millie that there were 26 new members and 3 members converted to life membership. Millie sent thanks to all who have helped her as Registrar of the American Clan Gregor Society.

Tess James followed with the Historian report. Tess pointed out the importance of notifying the Registrar of all deaths and births. She will add any new deaths and births reported to her to the report to be given at the General meeting. Both reports were accepted as presented.

Lillian Magruder, Yearbook Editor, presented her report to the Council, which was accepted as presented. Lillian thanked all those who sent in pictures for the Yearbook and impressed on everyone to notify her of any changes in telephone #'s, especially changes in area codes. March 1st is the deadline for the Yearbook so please have your submissions in by Feb. 1st 2002. A motion was made to accept the report of the Yearbook Editor, seconded and passed.

There was no report from Marshall Grier, Librarian elect, who was absent. Joe reported that the Black Book of Taymonth is now available in our Library.

Hallam Walker gave the Council the scholarship report. This year there were no applications for the Blunt Scholarship; a discussion followed and it was agreed that we should make our membership aware of the availability of a scholarship for their children entering College. Our Chieftain suggested that we should publish an article on the application for scholarships in our Newsletter and on our Website. This was readily agreed to. Ron McGregor asked if the scholarship money could be available thru application from other than the direct parents. Ron was referring to a Colorado auto accident where the parents were both killed. Joe replied that this case and all similar cases would be granted a waiver. A motion was made to accept the Scholarship Report as presented, seconded and passed.

The previously circulated list of e-mail addresses was passed back to John McGregor and Jeffrey encouraged everyone to use this very useful tool to communicate. Jeffrey further stated that his e-mail address as published on the society letterhead is incorrect. His correct e-mail address is jrmcgreg@bellsouth.net.

There was no report from the Trustees.

Newsletter Editor Ron McGregor gave his report to the Council. Ron expects to publish our next Newsletter in early December. He would appreciate a note of season's greetings from the Council Members. Apparently, we are having a problem contacting members who have moved. The post office only forwards mail for three months after addresses have moved and a fair percentage of our mail is not delivered. It was suggested that members who move publish their new address on our web site. Ron offered to list members, whose current address is unknown, in his Newsletter. Hopefully, someone will recognize them and they will get in touch.

Ron's report was accepted as presented.

Jeffrey suggested that we ask Jim McGregor to post our 'lost' members on the web site.

The Assistant Chieftain, Joe Tichy, gave his report to the Council. Joe announced we were in good shape and also in good company. We have added 26 new members and 7 of our members have passed on; with our "lost of address of active members," we come out about the same as last year. Joe stated that he attends a postal seminar every year and the post office has become very strict in their requirements for mail delivery. The Post Office requires addresses be in all capital letters, no commas or periods, Mr & Mrs must be without periods etc. It is necessary to have every address exact, so please check your address in our Directory and notify Joe if there are any errors. There will be a new directory coming out in the near future.

Bill Tyler has been nominated as the new Registrar; the transition of Registrar is going to take some time. All the records have to be transferred from Millie in Pensacola to Bill in Virginia. These files are quite bulky. Joe indicated that the material to be picked up from Millie was mainly two file cabinets containing about 2500 applications dating back to 1909. Bill said he could handle this and would visit Millie for some indoctrination and pick up the files. Bill stated that he does not like handling papers and would work on getting as much as possible on disk. This is a huge task; it was suggested that once Bill has everything on disk the paper records would be stored in our library in Baltimore. Details of this report will be given at the General Meeting. The Assistant Chieftain's report was accepted as presented.

Chieftain Jeffrey McGregor announced he would reserve his remarks until the General Meeting.

Under Unfinished Business, John McGregor made a motion to send a nominal sum of money to the Clan Gregor Society for the preservation of artifacts and restoration of sites related to our heritage.

In the ensuing discussion it was pointed out that we cannot send any money to Scotland as we have not yet collected any monies. It was clarified that the scribe's motion called for a 'nominal' sum be sent to honor the commitment made last year. Joe further indicated that we did not commit ourselves to any timetable for these donations and the scribe who read the appropriate paragraph from the year 2000 AGM minutes later confirmed this.

The motion was restated, seconded and passed.

A new motion was made from the floor that we send an amount of \$1,000 to the CGS. Some discussion took place as to the mechanics of collecting and accounting for the fund and our Chancellor was asked if she could advise on our setting up a 501 C3 fund. Jeffrey requested that the pledge card and covering letter already drafted by Malcolm be made available to our Chancellor.

After a period of discussion, the motion was restated to send a \$1000 donation to CGS, seconded and passed unanimously.

Under New Business, Ron McGregor informed us that Glengyle House has been offered for Sale by the Water Board. The House is in poor repair and is being offered for 220,000 pounds. It appears that preserving this site would be very expensive, it would cost an additional \$500,000 to get it in livable condition. If the Scottish Preservation Society were to declare it an historical site, no changes could be made other than upkeep. At the moment it appears that there are too many obstacles to make this a feasible undertaking. Ron brought to our attention another project of the Clan Gregor Society. The Scottish Clan Gregor Pipe Band is in need of funds; they are expanding the Band and need uniforms and funds for transportation to enter competitions.

It was suggested that a notice be placed in a Newsletter and anyone who wished, could support this worthy cause.

Thad Osborne informed us that Clan Gregor would be the Honored Clan at the 2005 Games in Gatlinburg TN - make your plans accordingly!

The Deputy Chieftain of Georgia brought to the attention of the Council that the Stone Mountain Games take place in the last week in October and coincides with the dates of our

Gathering. Joe Tichy informed us that next year's Gathering will be held the first weekend in October in Harrisburg, PA; this should provide a break between the two events. More details of next year's gathering will be made available at the General Meeting.

In the absence of Malcolm MacGregor, Joe Tichy presented the Nominating Committee's slate of new officers and Trustees for the coming year.

A motion was made and approved to accept the slate of officers to be presented to the General Membership for a vote.

With the concurrence of the Council, Chieftain Jeffrey McGregor appointed Joe Tichy as Assistant Chieftain and Carrington Ewell as Deputy Assistant Chieftain.

At this point an inquiry was made as to our participation in the 2003 Gathering in Scotland for the 400th Anniversary of Glenfruin. Ron McGregor updated everyone on this event and encouraged anyone interested to make reservations immediately as there is accommodation available for only 200.

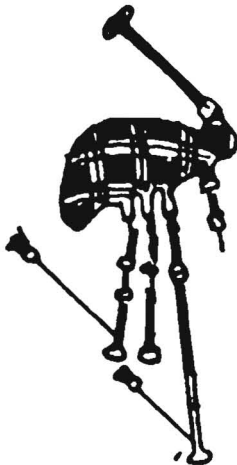

AMERICAN CLAN GREGOR SOCIETY GENERAL MEETING — OCTOBER 13th, 2001

Chieftain Jeffrey McGregor called the 92nd meeting of The American Clan Gregor Society to order on October 13th 2001 at 1:25 pm with the words "Children of the Mist, the MacGregors are here". Our Chieftain brought greetings from Scotland. Sir Gregor MacGregor of MacGregor and his wife Fanny extend their glad tidings to all American Clan Gregor Society Members and their families. Sir Gregor further wished us a successful gathering and a safe journey as we return home at the conclusion of this Gathering.

On behalf of the members of the Council and the Officers of the Society, Our Chieftain extended his greetings and a hand of friendship to all present.

The meeting began with the invocation given by the Rev. William McGregor.

John McGregor, Scribe was called upon to read the minutes of the 2001 Council meeting. A motion was made and seconded to accept the minutes as read. Motion carried. A motion was made and seconded to accept the minutes of the 2000 General Meeting as recorded in the yearbook. Motion Carried.

Treasurer Sandy MacGregor gave the Treasurer's report. Sandy reported an Income of \$26,990.00, total Interest/Dividends of \$18,489.97, Projected Int/Div \$1,188.00. Total income \$46,667.97 and total Expenses of \$32,419.38 leaving a positive cash flow difference of \$14,248.59. Sandy reported there were no extraordinary expenses this year. Annual dues received for 2000/2001 were \$8,420.00. Cash on hand is \$19,311.49. Savings account balance of \$28,358.09. Short term Investment value of \$265,910.06. Net worth this year is \$235,557.03. The Treasurer's Report was accepted as presented and will be published in its entirety in our next Yearbook.

Our Chieftain called for the Registrar's report. Our Registrar, Millie Gregg was unable to attend due to illness. Tess James gave the report. The report indicates that there were 26 new members, 3 members converted to Life members and there were 4 new Jr. members. The Registrars report was accepted as presented.

Historian-Elect Tess James presented the Historian's report. Tess read aloud to the audience the names of eight who passed away this year. 3 weddings and 2 births were reported. Tess requested that if anyone hears of the death of one of our members or any statistics related to our Clan to notify her.

Yearbook Editor Lillian Magruder gave her report and thanked the members for all the pictures that were sent in and to please continue to do so. The deadline for the yearbook is March 1st but she emphasized the need to send all articles and pictures in as early as possible. All articles would be gratefully received and it would make our yearbook more interesting.

The Librarian-Elect Marshall Grier was unable to attend and no report was given.

Hallam Walker gave the report of the Scholarship Committee. He reported that there were no applications for scholarships. It was his opinion that although we have advertised the guidelines for the Scholarship program, we are not reaching enough people and after discussing this with our Chieftain he felt we should publicize the program on the Net and in our Newsletter. The directions for application will be on our web site as well as in our Newsletter.

Ron McGregor, the Newsletter Editor, was called upon to give his report. Every member should have received the Newsletter; if this is not so then it is likely that we do not have a correct address, so please check your address in the Society Directory. The next Newsletter is due out the 1st week of December, so please get your articles in by mid November. Photos would be welcome and any not used would be put in the Colorado State photo album.

Our Chieftain called Jim McGregor, our Web Master to the podium to introduce him and tell us a little about our Web site. The Web site has been up since 1997 the address is 'acgs.thecapitalscot.com' and you are encouraged to visit it. There is a worksheet for new members which when filled in can be sent to our Registrar electronically or by mail. Jim agreed that it was a good idea to put our Scholarship program on the Web.

Joe Tichy opened his Assistant Chieftains report by saying that our membership is about level with last year. There were 26 new members and 8 deaths. However, we have lost touch with some members due to postal problems, the post office will not deliver mail to anyone that has moved to a new address for more than 3 months. This means that if we are a little over three months with our mailings we lose the address of that member. So it is essential that you notify us of a change of address, otherwise you may get lost as a member. Our new directory is due to be printed shortly so it is important you notify us immediately of any change of address either yours or someone you know.

Joe introduced our new Registrar Bill Tyler and informed us that he would be taking over from Millie Gregg. Millie has been ill and so has her husband Paul, so it has been a very trying year for her. Bill will visit Millie and collect her records and take them to Virginia. Bill is in the process of moving from New Jersey to Virginia so it will take them some time to become all set up. Bill is a computer buff and plans to get as much of our records on disc as he can. If anyone has any problems locating Bill, please get in touch with Joe.

In regards to the Society contributing money to the Restoration and Preservation of Antiquities in Scotland, the pledge cards will go out with your Dues bill in January. Lifetime members will be sent pledge cards. The amount one gives is voluntary and will be an annual amount for 5 consecutive years.

Joe stated that this has been a wonderful Gathering and our thanks go to Ron McGregor, chairman of this Gathering. Ron has been tireless in his efforts to make this Gathering a success. One unusual thing Ron did was to get a list of all the McGregors who signed the visitors list at the games in Colorado; he came up with 200 names. Some of the names did not have a full postal address, however, Joe managed to send out the left-over invitations and letters of invitations to approximately 175 people and he was proud to announce that 15% of these people were here tonight. In such a mailing one would expect to get only about 5%

The Assistant Chieftains report was accepted as presented.

Chieftain Jeffrey McGregor began his address to the Gathering by thanking all of our Society Officers, who have given much of their time and effort to keep our Society active and running smoothly. There being no more 'Unfinished Business', the Chieftain moved on to 'New Business'.

Ron McGregor informed us that a photo backdrop had been set up outside for members to have their photos taken. He also reminded us that The Thistle and Shamrock, a store selling Scottish and Irish Merchandise were giving ACGS a special discount and had changed their hours to accommodate us.

There being no other new business Our Chieftain informed us that he had planned to call Millie Greg (Our retiring Registrar) to the podium to thank her for her service and improvements in the registration process and genealogy field. He has written a Certificate of Appreciation and will mail this to her as well as our best wishes for a speedy recovery.

MEMORIALS

ROBERT HARRISON SLAUGHTER, JR.

1918 - 2001

Robert Harrison Slaughter, Jr. died on Wednesday, March 14, 2001, at his home in Pascagoula, Mississippi. He was born on October 17, 1918, in Boise, Idaho. Mr. Slaughter had been a resident of Pascagoula since 1957. He was a graduate naval architect from Webb Institute of Naval Architecture, with a Masters degree from Massachusetts Institute of Technology. He joined the U.S. Navy in 1942, directly after graduation from Webb, and spent most of the war building warships at Norfolk Naval Shipyard. He remained in the Navy until 1956, retiring at the rank of Commander.

Robert Slaughter moved to Pascagoula in 1957, joining Ingalls Shipbuilding, where he worked for the remainder of his career. He attained the position of Vice-President/Nuclear Power, and was a key player in the construction and launch of numerous nuclear submarines built by Ingalls. He retired from Ingalls in 1988.

He was also active in community affairs, serving on the Pascagoula Planning Commission and for 30 years on the Mississippi Gulf Coast Junior College District Board of Trustees. He was a District Commander for the United States Power Squadrons, and was a life member of the Society of Naval Architects and the American Society of Naval Engineers.

His father, Robert Harrison Slaughter; his mother, Louise Templeton Slaughter; and one brother, Blair Slaughter, preceded him in death.

Survivors include his wife, Harriet Ridick Slaughter; two sons, Robert Slaughter of Aiken, South Carolina and Stephen Slaughter of Costa Mesa, California; daughter Janet Slaughter Davenport of Allen, Texas; sister Eileen Slaughter of Wheaton, Maryland; and six grandchildren.

These ladies enthusiastically took to the dance floor while beckoning their clansmen to join the fun. But, like all valiant fighters, the crowd of MacGregors stood their ground and would not budge. I considered joining the girls myself. However, my Scottish dancing has an uncanny resemblance to the ChaCha; I thought it best not to confuse people.

I am honored to say that on Saturday morning I attended my first council meeting as a member-at-large. My source informed me that my new position was considerably more important than, say, a member-at-medium or at-small. Thusly, feeling very important, my first official act was to propose that council members receive substantial salaries and travel allowances. My motion was tabled, however, when we could not agree if we should make one or two trips to Scotland each year.

I'm just kidding.

Seriously, I must say that the business of the Clan MacGregor is no small undertaking and that your officers are hard working and very dedicated to the success of the clan. We should be very proud and thankful for the efforts they put forth.

Speaking of gratitude, we must not forget Ron Macgregor and his many assistants for their monumental efforts in organizing and executing a rewarding and memorable gathering. Thank you all.!

While I was occupied with the affairs of the Council on Saturday morning, an informative and interesting genealogy meeting was also underway. Chaired by Howard Grossnickle, the meeting featured several presentations that not only highlighted the history of the MacGregors

2001 Annual Report for Colorado

This has been the busiest year yet for this Deputy Chieftain, and I now have a method of providing myself with an overview of how I have been spending my time in support of Clan Gregor. In March, it was suggested that I should keep a running log of my activities involving Clan Gregor activities. Since I try to check my e-mail daily, I found it easy to open a worksheet and just before turning off the computer each evening, I make the appropriate entries.

In **February**, I attended a reception representing the Clan Gregor. The reception was held at the famous Buckhorn Exchange Restaurant in Denver, to celebrate the publishing of the new novel "MacGregor's Lantern" by Corinne Brown. The author included in her acknowledgements: Susan Thornton, who traces her heritage to Clan Gregor and was a "Special Guest" at this year's Gathering; Loretta Thompson, who provided entertainment at the Gathering's Ceilidh; and me. Like Susan and Loretta, I was surprised and honored that Corinne felt that our inputs were worthy of note. Corinne attended our Gathering and provided a dramatic reading from the book.

On **April 6th** I was joined by Howard Grossnickle (ACGS #2638) and my son Scott to represent Clan Gregor in the annual Tartan Day ceremonies at our state Capitol.

On **April 29th**, I represented the ACGS at the annual "Kirkin' of the Tartan" at Denver's St. John's Cathedral. This year's service was to be especially meaningful for Clan Gregor, as two members of our clan were honored to be selected to be tartan bearers during the services. In addition, of even more significance, it was the first time that a husband and wife of Clan Gregor was selected. We were very proud that Scott and Heather McGregor were selected (along with four others) to carry the tartans of the various clans to the high altar to be blessed. Unfortunately, two days before the Kirkin', Scott came down with a severe case of the flu and with Heather having been exposed as well, this meant that neither would be able to attend. Ann and I had to be out of town so once again I called upon Howard Grossnickle as a supportive kinsman and friend (and on short notice) to take Scott's place. It seems as though we are frequently finding reasons to "thank" Howard for his assistance and he has never failed us.

On **May 12th-13th**, the ninth annual **Kiowa Celtic Festival** was held in Kiowa, Colorado. When members of the ACGS first began attending these games just a few short years ago, there were only five clan tents along Clan Row for the one-day event. It has grown to a two-day event and this year had about thirty-five clans in attendance, and is now the third largest Scottish Games in Colorado. Howard Grossnickle of the ACGS and Jerry Walker of Cheyenne, Wyoming jointly hosted the Clan Gregor tent. Our thanks are added to the thanks of dozens of Clan Gregor types who visited our clan tent for their efforts in our behalf.

On **June 2nd**, "**MacGregor-The Musical**" - We here in Colorado were afforded a truly exceptional opportunity. Last year Howard Grossnickle came across an obscure article regarding a stage production being developed in London titled "MacGregor". Howard established contact with the writer/producer, Mr. Max Bartoli, in London and over several weeks of phone calls and e-mails arranged for Mr. Bartoli to visit us in February. One thing led to another and thanks to Howard, Mr. Bartoli agreed to return to Denver in three months time and give a free performance for the ACGS MacGregors of Colorado and our Celtic friends. Mr. Bartoli rented a newly built and very well equipped theater for the occasion. By putting in countless hours in arranging for musicians, actors/singers, selecting tunes, finding a rehearsal hall, coordinating with the lighting and sound technicians along with a myriad of other important details, Mr. Bartoli, Howard Grossnickle and Ms. Loretta Thompson (a professional entertainer and long time supporter of Clan Gregor activities here in Colorado), the preview of the musical was presented. In addition, we were doubly honored that past ACGS Chieftain Abbey Magruder and his wife, Lillian, and Joe Tichy took time from their busy schedules to come to Denver to attend the performance.

On **August 11th and 12th**, the **Colorado Scottish Festival** was held in the south Denver suburb of Highlands Ranch. It was a perfect weekend for us. Over forty MacGregor types visited our Clan tent. Several of them were 'first timers' to the Scottish Games and Clan Row. One of the 'first timers' was a middle age lady of Clan Gregor who was born and raised in Scotland and admitted that she had learned more about the history of Clan Gregor in the hour or so that she visited our tent than in all of her years growing up in Scotland. I find myself asking the question 'How is that possible?' Most of the 'first timers' were surprised and impressed that "their clan" had an organization, much less "Gatherings", and seemed thrilled to learn that they would have the opportunity to attend this year's Gathering here in Denver. Corinne Brown not only visited our tent but arrived bearing gifts - copies of her book *"MacGregor's Lantern"* which she autographed for us. She even accepted our invitation to join us in the Parade of Clans and carried one of our seven tartan flags. Loretta Thompson visited with us between her performances and discussed her plans for the entertainment at our Friday evening Ceilidh during the Gathering. The people manning the Clan Campbell tent were surprised to learn that we MacGregors had a copy of "The Black Book of Taymouth" on display at our tent, particularly since none of them at the Campbell tent had even seen a copy of the book before. (Strike one up for the Gregarach.) Catherine Calvert of Houston, Texas won the Clan Gregor trophy for the best Novice Highland Dancer under the age of eleven.

On **September 6th-9th**, the **Longs Peak Highland Festival** was held in Estes Park, Colorado. This year proved to be another banner year for Clan Gregor. In 1999, Clan Gregor made a clean sweep of the Clan awards, beating out 70 other clans, and was declared the Outstanding Clan of the Games. Last year we were not eligible to compete, as we had to provide judges for the Clan competitions. This year was the first time we could compete again, and again, we beat out the other 70 clans in attendance to make another clean sweep of the awards and once again declared the Outstanding Clan of the Games. The Longs Peak Games is the largest Celtic festival in the Rocky Mountain region, so we are truly proud of our accomplishments.

Beginning on **September 11th**, in response to the terrorist attacks earlier that day in New York, the Pentagon, and in the skies over Pennsylvania, I received and responded to thirty e-mails from our kinsmen from here and abroad. They were tender and moving notes of condolences, solace, and support. The very first messages received were from Sir Gregor and Lady MacGregor, Helen Garrett (CGS & ACGS member with husband Bill were staying in Edinburgh at the time), Isabel McGregor (Secretary of the CGS), Richard McGregor (Chairman of the Council CGS), O. V. Lundin (CGS member from New Zealand), Jimmy and Angela McGregor (CGS members from England), and Carolynne McGregor-Long (CGS member and ACGS Deputy Chieftain for California). Many more were received illustrating the strong ties that bind the men and women of our Clan.

On **September 29th and 30th** I hosted the Clan Gregor tent at the **Grand Junction Scottish Festival**. This was their first two-day event and it is growing each year. Local Clan Gregor types have been instrumental in the success of these Games. One couple in particular stands out for well-deserved recognition - Mike and Dee Henjy. Mike chairs the athletic events group (and also participates), while Dee chairs the Clans committee. We also have Clan Gregor dancers, pipers and drummers residing there.

October 11th-13th had us hosting this year's ACGS Gathering. Randy Zimmerman's report on the Gathering will be included in the next issue of the ACGS Yearbook.

Summary: For those that prefer numbers to support subjective reports I offer the following. In direct support of the American Clan Gregor Society and/or Clan Gregor activities in general: I received or made over one hundred local phone calls and forty long distanced phone calls (including several overseas calls). I sent or received almost 400 e-mails and more than 160 letters and packages. I spent almost seventy hours preparing this year's three issues of the "Ardchoille". 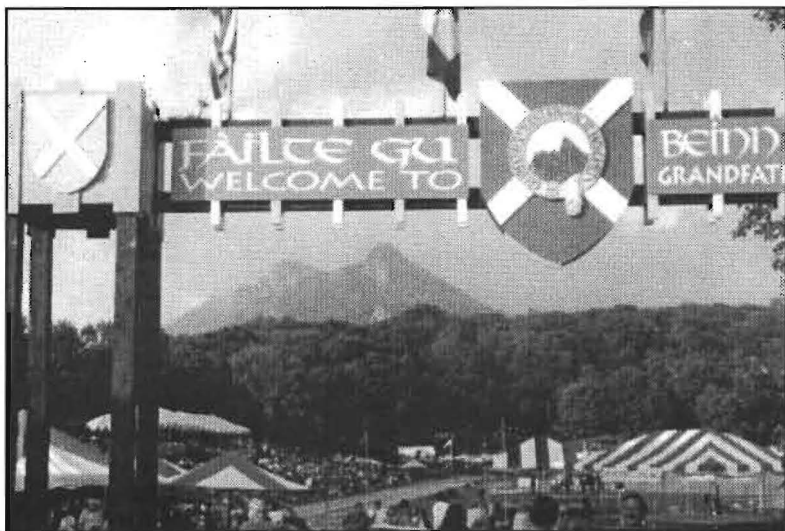
Alison Azbell ran the kilted mile in her age group and came in second. Next year she will run in a different age group and plans to come in first. We were all very proud of her.

Editor's Note: Each year we reprint an article of interest from a past yearbook. This year I have chosen to go back 73 years to the 1929 yearbook. I have chosen an article on "Windsor", a large plantation home of the late 1800s here in our home state of Mississippi. The "Ruins of Windsor" is now the property of the State of Mississippi, having been deeded to the state by the Magruder family who inherited it. It is a very interesting place to visit. I hope that each of you will enjoy reading about it.

"WINDSOR"

With assistance from others I have written this sketch of Windsor.—

Nannie Hughes Magruder

The winds made weird music through the huge capitals. Thus it gained the name of "Windsor" and not from any fancied resemblance to Windsor Castle as many suppose. Situate on a plantation of about two thousand acres east of the Mississippi river, not far from historic Bruinsburg (made so by the landing of Grant's army) stand the ruins of a once magnificent home, viewed by tourists with wonder and delight. Twenty-four Corinthian columns with their capitals mutely attest its former grandeur. What thoughts come to us as we look upon them. How mutable are human affairs. Yet clinging tenderly about these columns is the old Virginia creeper, God's handiwork making them even more beautiful — whispering, God is, God is.

Windsor was built by Smith Coffee Daniell (born Oct. 10, 1826 — died April 28, 1861) who was married, Jan. 9, 1849, to Catharine Skinner Freeland (born Aug. 31, 1830 — died March 6, 1903). They were cousins being grand children of Catharine (Magruder) Skinner. At that time he was a young planter of thirty-four years, a graduate of Oakland College under its first president, Jeremiah Chamberlain. He was a man of wealth, culture and refinement combined with an innate love for the beautiful as the building of this home exemplifies. I have been told that he planned this home during an illness of long duration, showing a spirit of rare unselfishness in that he had no thought of self, but that those near and dear to him might find enjoyment in its beauty, and also instruction from the splendid library of his selection.

There were thirty-two rooms in Windsor. Its spacious hall was supported on the interior by a number of large columns. There were four entrances with seventeen iron steps leading to each. I could not give in detail the elegance of its interior furnishing but one cannot recall this home without remembering the marble mantels, mirrors reaching from floor to ceiling, old furniture of carved rose-wood upholstered in crimson brocade with draperies to match; another room in green brocade; the library with its green hangings and oak bookcases; also, the hall and dining room in oak. The mention of the dining room brings to memory the set of exquisite imported china with a band of pink and gold and the Daniell monogram in gold. Very much enjoyed by visitors to Windsor was the observatory where one could view the surrounding country for miles.

Windsor was ready for occupancy in March, 1861. The death of Mr. Daniell occurred one month after moving with his family into this home. He is buried in the family cemetery on Windsor plantation. After this sorrow war came with its devastation. One of his sons, who was quite a small boy at the time, remembers the landing of General Grant and his army at Bruinsburg on the way to Vicksburg. Indelibly stamped on his memory is a vivid picture of this army, not moving in columns, but spread out with bayonets fixed and deployed as skirmishers (to use the military term) they marched through the broad fields of Windsor and about the grounds. After the battle of Port Gibson the wounded Union soldiers were brought to Windsor and the house became a hospital. For this purpose all the furniture except from the hall and library was removed, the library being used by the surgeon Dr. Loid (Lloyd), a man of refinement and culture. The few who still live and remember him have not forgotten his unfailing kindness to everyone. The dead men, numbering between fifty and sixty, were buried between two large red oak trees, where they remained until moved to their final resting place. Strange to relate this house passed through the war uninjured, though it had some narrow escapes. And though supposed to be fire proof, it was burned in 1890 and how and where the fire originated still remains a mystery.

While the war brought many changes in the old neighborhood in and around Windsor, the sorrow and devastation were bravely borne. The family became adapted to the change of circumstances and Windsor again became the social center because of its gracious hospitality. Here the daughter of the home grew from girlhood into charming, vivacious womanhood, endowed with all those attributes of character that make for popularity and with her many Christian virtues she has lived beloved by friends and relatives.

And here in her home at Windsor she met Joseph Moore Magruder who was then living at Bruinsburg plantation, he having the place in charge for a New Orleans firm. Very shy and reserved he at once fell a victim to her vivaciousness and charm and, like the proverbial fairy tale, it ended with a wedding at Windsor — one long to be remembered by the guests who were present.

In the family Bible is written — "Married at Windsor plantation, December 13th, 1888, by the Rev. D. A. Planck, Priscilla Daniell to Joseph Moore Magruder".

Among the graves at Windsor are those of Smith Coffee Daniell and his wife, their grand mother, Catharine (Magruder) Skinner (1777-1837), and an infant daughter of Priscilla (Daniell) Magruder the present owner of the plantation.

Editor's Note: When I accepted the position as Editor of our Yearbook, I started a new tradition of reprinting a biographical sketch from one of the early yearbooks. These sketches are most interesting and a very valuable source of genealogical information. I continue to hope that some of you may be encouraged to submit a sketch of an ancestor for inclusion in a current yearbook. This year I have chosen a sketch on Hiram Drane, which comes from the 1929 yearbook.

HIRAM DRANE

(Cassandra Magruder Drane, Ninian Beall Magruder,

Samuel 3rd, Ninian, Samuel, Alexander)

Hiram Drane, born on his father's place in Columbia County, Georgia, February 20th, 1806, was the fourth son of William and Cassandra (Magruder) Drane, who were originally from Maryland.

His mother, Cassandra Magruder, born in Montgomery County, Maryland, September 13th, 1768, died in Talbot County, Georgia, February 26th, 1860, was daughter of Ninian Beall and Rebecca (Young) Magruder, and his father, William Drane, born in Prince George's County, Maryland, July 14th, 1765, died in Columbia County, Georgia, February 6, 1847, was son of Anthony Drane, of Prince George's County, Maryland, a Revolutionary patriot.

After the War for Independence, many families came from Maryland to Georgia. William Drane and his brother Walter Drane were among the early pioneers who established their home in Columbia County. Ninian Beall Magruder and his first cousin Ninian Offutt Magruder, with their families, also came to Georgia, taking up military grants and established themselves on large plantations in Columbia County. It will be remembered, however, that Columbia was carved from Richmond County, in the year 1790 and their lands, though originally in Richmond County fell in the new county of Columbia.

The history of the two families of Magruder, as well as that of the two Drane brothers has been irrevocably linked together. The two Drane brothers, married daughters of Ninian Beall Magruder.

Hiram Drane spent his boyhood on his father's plantation in Columbia County, Georgia. He grew up to manhood with only the rudiments of an "old field education." His early life was spent in hard work on the farm, where he acquired a knowledge of surveying.

On December 20th, 1827, he married his cousin Eleanor Magruder, (Eleanor, John, Ninian Offutt, Ninian, Ninian, Samuel, Alexander). She was born in Columbia County, Georgia, July 20th, 1809, daughter of John and Sarah (Pryor) Magruder, and grand-daughter of Ninian Offutt and Mary (Harris) Magruder.

Hiram Drane lived in Columbia County, Georgia, until the year 1833, the year the stars fell, when he moved his family to Taylor County, Georgia, his new home being located near

the lines of Talbot and Taylor Counties. When he made this move he had accumulated about eight hundred acres of land in Columbia County. His wife Eleanor inherited some property and slaves from her Uncle Archibald Magruder, a bachelor, who had accumulated considerable property. (This Archibald Magruder was son of Ninian Offutt Magruder, and had been a soldier in the American Revolution. His will, made March 22, 1837, probated May 6, 1839, is on record in Will Book W, pages 424, 5, 6 and 7, of Columbia County, Georgia. He made bequests to his nieces and nephews, children of his brothers George, Zadock and John Magruder, and sisters Sarah Olive and Nelly Wynne. He is buried in the Magruder burying ground a few miles from Harlem, Georgia).

Hiram Drane was a Democrat, and served one or two terms in the Georgia Legislature sometime before the War between the States. He was considered too old for active military service, so remained at home to furnish provisions for the army. He served a long while as Justice of the Peace, belonged to the county court, and was known as "Judge Drane".

Freedom came to his slaves with the closing of the war. In the summer of 1865 he worked them as he had in slavery times, finishing the crops already planted. In the fall he sold all his personal property and land at public auction, leaving each negro enough provisions to carry him through the winter - he had about twenty slaves at this time - and went to Mississippi. He could not see his way clear to pay his former slaves for the work that they would have to do, so left to get into entirely new surroundings.

When he made this decision, he and one or two of his sons-in-law, journeyed to Memphis, Tennessee, by train; secured horses and scouted around in northern Mississippi to locate some land. The old "Brown" plantation, containing a large acreage in DeSoto County, near Cockrum, appealed to him. This he purchased and returned to Georgia for the family.

Three of his married daughters and their husbands went to Mississippi also. The daughters were Julia, wife of Charles Knowlton; Elizabeth, wife of Henry Manes; and Martha, wife of James Matthews. The trip was made by train to Memphis, and then by private conveyance to Cockrum.

The three sons, Patrick Henry, Andrew Jackson and Hiram Walker Drane, drove wagons through the country with the household effects on the move from Georgia. Two other families accompanied the party. They were three weeks making the journey. They had a large tent for rainy weather, which was used only the first night out, the weather continuing fair and frosty the rest of the time. Hiram Walter Drane was only fifteen years of age at the time, but he was made treasurer, going ahead to arrange provisions for the members of the party and the animals. Hiram had instructed his sons not to travel on Sundays. One day they passed a meeting house where services were being held. They thought they were disobeying their father's injunction, however, they soon came to a place where hog-killing was going forward, and concluded that it was Saturday, and that it was the usual business session that was being held at the other place.

The party crossed the Chattahoochee River at Columbus, Georgia, and while camped out near them, some of Wilson's raiders passed and fired off guns. No damage was done and they were not further molested on their trip. The journey continued through Tuscaloosa.

Alabama, where the river had to be forded as the bridge had been burned, thence to Aberdeen, Mississippi and on to Cockrum.

Hiram Drane acquired more land on the Pidgeon Roost Creek, mostly forests, also property on Bear Tail Creek, meanwhile securing a residence containing a large acreage in the village of Cockrum.

Eleanor Magruder, his first wife, was a Methodist, but Hiram Drane joined the Presbyterian Church at the age of fifty. He would ride horseback in all kinds of weather to attend services at Hernando. Part of this ride would be through Cold Water Bottoms, and frequently he would be covered with mud to his waist on his return.

He had a reputation for honesty. He always paid his debts promptly, and believed in giving good measure, pressed down, shaken together and running over, and would never accept more than the legal rate of interest when lending money, and less from widows.

He was a man of considerable sense of humor. Once a Dr. Matthews had been seeing a slave for some months without curing her. Hiram, believing her a malingerer, had her tied up in a blanket for transportation since she was so ill, causing all the other slaves to laugh at her. This worked a cure, and the good old Doctor always resented the laughter that was evoked when it was said that Hiram cured with a blanket in one day what he couldn't cure in a month.

The last days of Judge Drane were spent confined in an invalid's chair, and having long passed the usual three score and ten, he entered into rest on the 14th of September, 1889, and his remains are interred at Cockrum, Mississippi.

The family record of Hiram Drane is contained in a bible published by Sumner and Goodman, Hartford, in 1848, and is now in possession of Hiram Walter Drane, Memphis, Tenn.

According to this bible record "Eleanor Drane died in the year of our Lord 1870, on the 19th of November, ten minutes before one o'clock P.M."

Hiram Drane married secondly Mrs. Electra Ann Jackson "whose maiden name was Haughton" born February 8th, 1823. She died "in the year of our Lord 1878 on the 13th day of January at 30 minutes after 4 A.M." There were no children by the second marriage.
