Post Traumatic Stress Disorder: A Neurological Perspective

To realize the potential widespread of Post-Traumatic Stress Disorder (PTSD), one need only refer to the criteria for the disorder as described in the DSM-III-R; "The person has experienced an event that is outside the range of usual human experience and that would be markedly distressing to almost anyone, e.g., serious threat to one's life or physical integrity; serious threat or harm to one's children, spouse, or other close relatives and friends; sudden destruction of one's home or community; or seeing another person who has recently been or is being seriously injured or killed as the result of an accident or violence."

Kinzie (1989) states that nightmares, shaking, persistent fear, and phobic behavior were described by famous writers such as Shakespeare and Dickens (all after-effects of traumatic events). Often ignored from both world wars were the long term follow-up studies that demonstrated in many the unremitting persistence of symptoms such as sleep disturbance, recurrent nightmares, intrusive thinking, an abnormal startle reaction, propensity to exacerbation of symptoms when exposed to stimuli reminiscent of the trauma, irritability and angry explosiveness, Kardiner (1941), Kolb (1990). However, it was not until the Third Edition of the Diagnostic and Statistical Manual of Mental Disorders (DSM-III, 1980) that the disorder was identified specifically as Post-Traumatic Stress Disorder, as an Axis I diagnosis, and listed with the group of anxiety disorders. This was followed by studies reporting the investigation of Post-Traumatic Stress Disorder (PTSD) in childhood. At the 137th Annual Meeting of the American Psychiatric Association in 1984 a symposium was devoted to furthering the understanding of the often profound impact of traumatic occurrences on the lives of children. Among the presentations at this meeting were those pertaining to children who were traumatized as a result of witnessing acts of personal violence, catastrophic situations, cancer, physical abuse, incest, trauma and grief, Eth, Pynoos (1985).

Four years later in 1988, in a symposium on biological assessment and treatment of PTSD, the progress made in providing an increasing clarification of the structure and dynamics of the disorder were outlined at the annual meeting of the American Psychiatric Association. The consensus was that the clinical picture of PTSD is often complex, especially with chronic PTSD, where it is often overlaid by substance abuse and questions of character pathology. When the stress is overwhelmingly traumatic PTSD can develop. The extent to which PTSD is composed of a prolongation of the acute stress response with the addition of other symptoms is not clear.

PTSD has specific and non-specific symptoms. Intrusive symptoms such as recurrent thoughts or nightmares about the trauma are relatively specific to the traumatic event. Symptoms less specific to the traumatic event are avoidance of thoughts or feelings about the trauma, sometimes extending to general psychic numbing, detachment from others, and/or a restricted range of affect. Finally, symptoms of increased arousal (e.g., sleep difficulty, irritability, hypervigilance, increased startle reaction, difficulty concentrating) are less specific for PTSD. Giller, Jr. (1990) states that although psychosocial aspects clearly affect the development, severity, and duration of PTSD, there are major biological components to the pathophysiology of PTSD.

The characteristic symptoms of PTSD involve re-experiencing the traumatic event; numbing of responsiveness to or reduced involvement with, the external world; and a variety of autonomic, dysphoric, or cognitive symptoms. DSM-III recognizes two subtypes of PTSD: the acute form with an onset of symptoms within six months of the trauma and of symptoms of less than six months and

the chronic or delayed form with a duration of symptoms of six months or more (chronic) or with the onset of symptoms at least six months after the trauma (delayed). The DSM-III-R (1987) makes major changes on the emphasis of symptoms in PTSD. The stressor is explicitly listed in the definition. The other three groups of symptoms are (1) persistent experience of the traumatic event; (2) persistent avoidance of stimuli associated with the trauma, or numbing of general responsiveness; (3) persistent symptoms of increased arousal. All these symptoms must occur during the same period for at least one month.

The symptoms of PTSD are a combination of biological and psychological factors. Biologically, this is associated with a large autonomic sympathetic discharge, conditioned emotional response, sleep changes, fluctuations in the endogenous opioid peptides, and CNS noradrenergic hyperactivity. Psychologically PTSD was viewed as a traumatic neurosis; affective blocking and alexithymic or chronic depression; information processing with cognition as the central role; and premorbid personality style which greatly influences the defenses used in coping.

Differential diagnosis may be complicated by the presence of drug abuse, alcoholism, chronic pain or rage, and violent attacks. Adjustment reactions are a major differential diagnostic consideration.

Treatment - different treatment methods are needed for victims of acute trauma from those of chronic trauma or with chronic symptoms. Whatever the approach, treatment is often helpful but at times may be disappointing. Individual psychotherapy for acute traumatic disorders in healthy individuals is good, and time-limited therapy with emphasis on cognitive or emotional aspects is indicated. Group therapy should embody the basic principles of group therapy and be led by an experienced group therapist who has had some first hand experience with trauma. Inpatient treatment of a brief duration may be needed to treat some acute complications of PTSD (suicidal and violent behavior or the effects of drug abuse and alcohol).

Psychopharmacology - tricyclics for depression and sleep disorders; propranolol or clonidine for marked anxiety reactions and intrusive symptoms; and antipsychotics to ameliorate psychotic symptoms. Essentially, a combination of various types of treatment may be prescribed.

Prognosis - when symptoms are present for more than six months the disorder is chronic; the prognosis is less favorable and may result in severe impairment. Symptoms are also cyclical and may return following stress. Symptoms may return fully for a time after a period of stress or reminder of the traumatic events. Therapy as described can be helpful in enabling these individuals to return to and maintain their productivity.




