#### MINUTES OF THE ACGS COUNCIL MEETING

American Clan Gregor Society, Inc. 114th Annual Gathering – Virtual, Zoom Format Submitted by D. Jane Montmeny, Scribe September 15, 2023

Call to order was done by Scott MacGregor, Chieftain, at 12:02 EDT, September 15, 2023 in zoom format. Those in attendance were reminded to silence their cell phones. The Scribe did roll call of Council members and confirmed a quorum of eight, quorum of six is required. There were also eight guests in attendance in the zoom meeting. Excused Council members were Mark K. McGregor, Stacey Hodges, Charles Grierson, Elizabeth Magruder Joiner, Mary Byrd Pettanati, and John Bellassai.

Opening remarks given by Scott MacGregor, Chieftain, welcomed us to the council meeting and Gathering. Even though it has been a struggling year, the Society seems to be doing well in that members have stepped up to contribute in needed positions. Scott looks forward to the next year and working well together. Scott read remarks from Sir Malcolm MacGregor, Society Chief in Scotland. He was unable to join us this year because of a busy schedule at this time involved with the Scots Guard and a WWII Special Operations Unit. Sir Malcolm sends greetings from Scotland and wishes us well and success with our council meeting and the AGM tomorrow. Because of the death of Donald MacLaren of MacLaren, Sir Malcolm has assumed the role of Convenor of the Council of Scottish Chiefs, a role which he held previously. There was an address confusion in sending him a copy of the latest ACGS Yearbook, but that has been corrected and the Yearbook is on its way.

The reports from the following Council members had previously been distributed and were now presented in the meeting: Ranking Deputy Chieftain, Scribe, Registrar, Treasurer, Assistant Chieftain, Chaplain, Yearbook Editor, Librarian, Historian, Webmaster, and Trustees. Jane Montmeny presented reports for those who were not in attendance. (These reports are found elsewhere in the yearbook).

Invocation was given by Thad Osborne, Chaplain (delayed because of technical issue).

The Trustee report was presented by Jack Simon, chair of the Trustees. There was discussion re: recommendation to change Trustee rotation to four years vs. the current three years. The issue is in regards to complexity of financial and investment funds and availability of Trustee candidates. There is a need to work out the details; issue was tabled until 2024.

Reports from the standing committees had previously been distributed and were reviewed: Scholarship Committee, Heraldry Committee, Recognition Committee, Genealogy Committee, IT Committee, Financial Review Committee plus their recommendations, Merchandise Manager and Gathering Site Selection Committee. (These reports are found elsewhere in the yearbook).

Discussion pertaining to these reports:

In regards to scholarships and increasing costs of college, options were whether to increase the amount of each award vs. decreasing the number of awards. This has

been discussed by Trustees; their focus is on available funds and it would be difficult to triage applicants to determine who would receive awards. No change was recommended.

IT Committee: Social media platforms were discussed. There are two FaceBook pages, ACGS and CGS. Each one has unique administrators who check validity of information posted. Yet to be determined how best to report on the social media aspects along with the webmaster under the IT Committee.

Merchandise Manager: It was reported that the cost for shirts and mugs will be increasing based on overall cost plus the cost of mailing.

Nominating Committee: Peter Gregg read committee report with the slate of officers for 2024; the recommendations were approved. Rick Walker will be sending out the electronic ballot.

Scott MacGregor announced the Chieftain appointments for 2024 which were considered and approved.

Changes to Policy and Procedures: Those with no recommended changes this year are Area Deputy Chieftain, Chaplain, Historian, Librarian and Piper. During the zoom interim council meeting, August 16<sup>th</sup>, changes were reviewed and approved for the Registrar, Newsletter Editor, Webmaster, Yearbook Editor and Assistant Chieftain. A clarification in the Trustee P&P was that the checks for scholarship will be mailed to the home address of the student and made out to the institution designated in the scholarship application.

#### For the Good of the Order:

A Membership Years Recognition Pin/Ribbon was presented by Peter Gregg. The original idea was from Randy Walker at 2022 Gathering. Purpose of the recognition pin/ribbon is to make money for the Society. Member would purchase the pin (about \$15), Society would furnish the device signifying each 5 years of membership. Peter showed a military style medal with dark red ribbon. He is still researching vendors who could make the additional devices. A message was sent of the medal/ribbon, response was positive to continue with the project. The use of Amazon Smiles was discussed last year but the program was cancelled by Amazon in February 2023.

As there was no further business, Scott MacGregor adjourned the meeting at 2:18pm.

# MINUTES OF THE GENERAL MEMBERSHIP MEETING

(Annual Gathering)

The 2023 Annual General Meeting (AGM) of the American Clan Gregor Society was called to order September 16, 2023, by Scott MacGregor, Chieftain at 12:01pm. A quorum was established at 35 devices logged on, with more than one member involved at each. It was reported that 77 votes had been recorded for the slate of officers.

#### RANKING DEPUTY CHIEFTAIN

OH BOY! Watta Year! We have had resignations of the treasurer (yes, again) and multiple ADCs. We have retained a replacement accounting firm and submitted our tax returns for 2022. We have created a new position and the administrative support for that position. So tasks specifically related to the RDC were limited and pushed into second place in order to cover these other duties.

At the Gathering of 2022, Cindy Brammer was nominated and elected to become the new treasurer. She resigned in March 2023. Hence, the Council held an ad hoc meeting to re-appoint Bruce Whyte to the position of interim treasurer until the Gathering of 2023. There was really no choice for the Council or me as no one else knew our financial system.

At the same time, we sought a new accounting firm to assist with our basic financial needs and prepare and file our tax returns for 2022. The Moore CPA Firm, Marietta, GA, were confirmed as our new CPA firm (our tax returns were filed on time with the IRS).

#### Other resignations were:

- Keren Wade, ADC, Missouri East. Jeanne Lehr, Missouri West, is taking over until a replacement can be found;
- Cindy Brammer, ADC, Central Florida, ADC, Northern Florida. The ADC Georgia shall cover those positions for the immediate future.

In addition to fulfilling the role of treasurer, I had also been maintaining the membership database. It was decided to remove this component and create a standalone position of Membership Database Manager. This is an appointed position and the incumbent is not a member of Council. Jason Corder who lives in the Washington D.C. area, has been appointed to that position. We are currently finalizing the job description along with policies and procedures for that position.

As a result, I have not been as active an RDC as I had hoped. Nor that y'all would expect. I have worked closely with the new ADCs in North and South Carolina (Mary Byrd and Dustin Pettenatti from Raleigh, N.C. and Tom and Kathy Watkins from Bellhaven, N.C. who have just moved to Greenville N.C.). These four have shared staffing of Games in North and South Carolina and done a wonderful job.

As ADC for Georgia I attended the Blairsville Highland Games in June, 2023. It seemed that population had been waiting for the Games to return after Covid as they came out in huge numbers. We were lightly staffed and overwhelmed with visitors as usual.

With the assistance of the site selection committee, we researched the chosen city.

Requested proposals from hotels that fit our needs.

With the assistance of local members, toured hotels virtually and in person to ensure they are a good fit for our needs as well as add fun new events during the weekend.

Negotiated rates and terms for proposals and contracts.

Hopefully choose a hotel and execute contract prior to 2023 Virtual Gathering.

- 2. There were three interim zoom Council meetings during this year as follows:

ACGS Chieftain, Scott F. MacGregor, opened the interim meeting on Saturday March 11, 2023 at 10:10am, per zoom conference.

Scott opened the meeting by explaining that Cindy Brammer had submitted her resignation from the position of Treasurer on March 3, 2023, to be effective immediately, and he had accepted her resignation. The goal of this meeting was to review the current status of the Society finances and to fill the position of treasurer or possibly hire a bookkeeper. Bruce led the discussion by explaining the following actions that had led up to the current issues:

- Cindy was able to do the basic entries and payments but not the actual accounting.
- 2. A business account had been opened at the Truist Bank but the account was such that they refused to accept a check from ACGS.
- 3. An account was set up using personal funds but the Tichy Fund could not be separated from the General Checking account.
- 4. Finances for the Operating Account up to end of February was \$19,300. About \$1500 of that was the Tichy Fund.
- 5. There had been nothing done with the C&E accounts. There was about \$8400 in the 501C3 fund and earned dividends from last year and some in the Magruder Library Fund. Funds need to be available for 2023 Scholarships now.
- 6. Tax returns for the Operating Fund and the C&E account are due now.
- 7. The funds in the Merrill Lynch investment are \$778,893.

- 8. Payments to the ACGS credit card are way behind; about \$14,000 that includes the cost of the Gathering. The hotel was paid by credit card.
- 9. There are some invoices that have been lost/misplaced.
- 10. It took several weeks of legalities to transition from Bruce to Cindy and may take a similar time to transition to a new person, or to Bruce as an interim.

#### The following discussions took place:

- 1. Bruce had contacted four CPA firms and had a response from one which sounded positive and professional.
- 2. Bruce, as past Treasurer, would most likely be able to step into the position. He outlined three major issues:
  - a. Accounting software Quick Books(QB) desktop had been used and then changed to Quick Books on-line, which became a disaster. Cindy had most recently used QB desktop; Bruce has a Mac and not sure how compatible that will be. He is checking out Zoho software which is a QB look-alike.
  - b. Accounts payable credit card payments are behind.
  - Need to re-notify vendors to remove Cindy's name and replace her with an interim Treasurer.
- 3. Jack added that he, as Chairman of the Board of Trustees, is able to have Merrill Lynch take Cindy's name off and put Bruce's name on the investment accounts. The cash available from the Merrill Lynch investment dividends today is \$38,412; that amount is available for scholarships this year; applications have already been received.

In summary: there is cash, there are invoice's that need to be paid, they can be covered by appropriate movement of funds.

#### Finding a new Treasurer:

- Several members who were prospective treasurers have been asked but were not interested.
- 2. Jeanne asked if there is a way to simplify or streamline the process? Because of the C3 and C4 it would be hard, there would be a need to communicate between the two.
- 3. Scott has seen other societies have one person who handles the income/deposits and the treasurer pays invoices and writes the checks. Would that process reduce the load to any one person?
- 4. In talking to a CPA firm, Bruce requested help with bookkeeping, paying the taxes and all other duties. The cost to ACGS still needs to be determined.
- 5. Peter stated that he has two checks that were written for sold merchandise; when should he submit them? Follow-up on a similar check led to the discovery of the finance issues.
- 6. Seeing that Bruce, as the recent past Treasurer and has interacted with Cindy, he has been appointed as Interim Treasurer until a permanent Treasurer can be found.

Summary of process to move forward:

- 1. Bruce will try to straighten out the payments and funds.
- 2. Scott will write a letter, Bruce will review it, and it will be sent to the general membership seeking interest in filling the position.
- 3. After reviewing the Bylaws, when there is a vacancy in an elected position, the Chieftain can appoint a temporary person to the position with approval by Council in a meeting where there is a quorum. A future Council meeting needs to be scheduled.
- 4. Yearbook: need to update addresses of those whose last year's volume was returned; Michelle and Jeanne will work together on the project. Lois Ann is finishing the indexing, then Scott can merge the index in the volume, Michelle will have the addresses. Don't send to printer until funds are determined.
- 5. Gathering 2023 dates to be determined but probably in 3rd or 4th weekend of September.

As there was no further business, the meeting was adjourned at 11:10am.

Scott opened the meeting by stating the reasons for the meeting are to approve the appointment of an acting Treasurer and to determine dates for the 2023 Gathering.

- 1. Bruce Whyte was appointed to be the acting Treasurer until a permanent officer can be found. He will have authority to carry out all duties of the treasurer, including signing checks and contracts on behalf of ACGS. The vote was six in favor, one abstention; approved.
- 2. A list of possible dates (September-November) had been distributed for consideration. After discussion it was decided that the 2023 ACGS Gathering will be held on September 15 & 16 by zoom meetings.

Bruce provided an update on the status of the treasurer functions:

1. Bruce has had discussions with Sarah Moore, CPA, who works with QuickBooks and is a trainer for the product. She offered a 20% discount in the discussion. No definite decision was made at this time.

- 2. Bruce had a response from eight members expressing interest in the treasurer position and that has been narrowed down to two members. Bruce and Scott will conduct interviews with each of them.
- 3. The final QuickBooks report for 2022 still needs to be determined and Bruce is working on that.

Scott updated that the final changes of the 2022 Yearbook have been done. The final list of accurate addresses needs to be completed. Alaina will send out a Facebook posting asking members to be sure their contact information is correct on the ACGS website.

It was suggested that the six members who initially expressed interest in the treasurer position be kept in mind for possible other positions. It was also recommended that a similar approach of sending out a mass email be used for the still vacant webmaster position.

In regard to planning for the upcoming Gathering, Jane mentioned the Policies and Procedures (P&P) that will be up for routine review, see list below. Also, the P&P for a new position, Membership Database Manager, needs to be developed and Jane will create a draft for Bruce to complete. Because this will be a new position, there will need to be an addition to the Bylaws to be voted on in the Annual General Meeting.

As there was no further business, the meeting was adjourned at 11:36am.

ACGS Chieftain, Scott F. MacGregor, opened the interim council meeting on Wednesday August 16, 2023 at 5:06pm MDT, per zoom meeting. Jane Montmeny, Scribe, completed roll call and determined that seven voting council members were on the call; a quorum of six is required.

- Scott stated the main agenda for the meeting is to consider the recommended changes to the Policies and Procedures (P&P's) that are up for review this year. Copies of the P&Ps with changes had previously been distributed to the council members.
- 2. The following P&P's have no recommended changes for 2023: Area Deputy Chieftain, Chaplain, Historian, Librarian, and Piper.

- 3. The following P&P's have recommended changes for 2023:
  - a. Registrar: After discussion, proposed changes were approved.
  - b. Assistant Chieftain: After discussion, it was decided to place this P&P on hold until the P&P for the Membership Database Manager is created so duties can be coordinated.
  - c. Newsletter Editor: After discussion, proposed changes were approved.
  - d. Webmaster: After discussion, proposed changes were approved.
  - e. Yearbook Editor: After discussion, proposed changes were approved.
  - f. Trustees: After discussion, proposed changes were approved.
- 4. A proposal to lengthen the Trustee term to four years was put forth for two reasons,
  - a. Difficulty getting qualified volunteers for the Trustee position
  - b. Gain knowledge and experience to oversee a complex \$800,000 portfolio

Upon discussion it was stated that there is a volunteer to be appointed for this coming year plus another prospective volunteer for the following year. It was mentioned that the four-year term would throw off the election of a Trustee every year; further discussion is required.

- 5. During discussion it was noted that there were also suggested changes to the Bylaws. However, because the specified timelines for changes to the Bylaws were not met this year, the Scribe will track those changes to be submitted for approval in 2024.
- 6. During discussions, it was decided that in all documents the words "should" and "will" be changed to "shall," based on Robert's Rules of Order. Also, in P&Ps where it states a person is leaving a position, it should state the succeeding office by title or the Chieftain as receiving all records, documents and other items. The Scribe will make the changes in all appropriate documents.
- 7. Discussion on outstanding positions:
  - a. Webmaster: position still needs to be filled. Rick Walker shall assist with the Gathering as needed.
  - b. Nomination of a new Treasurer will come from the Nomination Committee. Membership Database Manager and Newsletter Editor shall be appointed upon approval by Council at the annual zoom meeting September 15<sup>th</sup>. They shall be invited to attend the zoom meeting.
  - c. Bruce stated that a new CPA firm has been selected and shall be submitted for approval at the zoom meeting. They may also be acting as bookkeeper which shall simplify the responsibilities of the Treasurer.
- 8. As there was no further business, the meeting was adjourned at 6:48pm MDT.

#### **TREASURER**

Submitted by Bruce MacGregor Whyte, Treasurer

Well, this last year can only be described as, well, Amazing. Crazy. No walk in the park. Fortunately, the fiscal aspects have been largely corrected and we can move forward with confidence that the numbers presented here will be accurate. This report breaks up the various components of the treasurer's position and the fiscal activity.

#### Personnel

Our treasurer, Cindy Brammer, who was elected as Treasurer at the Gathering of 2022, resigned in March. The Council appointed Bruce Whyte to be interim treasurer and a search was started to find a replacement. Unlike the previous 2-3 years, we had a wealth of volunteers with fiscal and bookkeeping experience offering to take over that role. The decision was difficult, but Mark McGregor (San Clemente, CA) was selected as "Acting Treasurer". His appointment will need to be ratified by the full membership. In the meantime, since we had commenced training Cindy, she had some of our business going to her directly or sent from me. Hence, some mail passed in transit and some missed the recipient. This resulted, in particular, with some members being asked to pay their overdue dues when they had been paid and vendors not being paid on time. So for all those people, I am deeply sorry, we did not have our procedures working properly.

Thanks are due to all those who offered to help in any capacity. It was truly heartening to have so much support from the Society. We did not waste the opportunity to see if any of the others who applied for the treasurer role were suitable for other positions. One person, Jason Corder, is taking on the new position of Membership Database Manager.

The change in the treasurer required changing all contacts, bank accounts, debit cards and credit cards, and determining who should have access to what and then establish credentials for those accessing those accounts. This has been a tiresome exercise considering it is only about 15 months since we did this last.

#### **Contracted CPA**

While the position of treasurer was being resolved, we had commenced a search for a replacement Certified Public Accountant (CPA). We sought interest from 4 different firms. Several were available but the Chieftain and I agreed on Sara Moore of The Moore CPA Firm in Marietta, GA. She was selected based on her wide experience with non-profit organizations, governmental accounting, academic roles and her willingness to help us move forward at a reduced rate. She started in April, not realizing just how much needed to be done to tidy up the finances. Since then, she has straightened out our financial records and filed our tax returns on time.

#### **General accounts**


The General Accounts include the general operating account (checking account) and the Tichy Memorial Fund (Tichy). The latter is used for supporting the band and other components of a Gathering as may be needed.



Total assets in the General accounts through the end of December 2022 were \$97,225, not greatly out of line with the previous year (\$92,242). These assets included a bequest of \$80,000 in 2017. When we received the bequest, we could

not obtain clear advice from the CPA firm at the time as to what we should do with it. It was agreed that until that decision was made, the entire amount should be invested and earn at least some monies. On maturation, the corpus plus any accrued interest would be transferred to the C&E account. That is what happened, but somewhere in that coding it was misplaced and then journaled back resulting in the appearance of multiple entries. The CPA is currently correcting this coding. The bequest is included within the C&E investments but will continue to appear during 2023.

The increased income in the general account is that of the Gathering in 2022 (Chart 1) compared to the same time of year in 2021. Income for the period May through July in 2022 was \$4,105 compared to \$0 in 2021, coinciding with the Gathering also (Chart 2).





Expenditures in 2022 were \$9,487 which was 70% lower than in 2021 (Chart 3). This was totally accounted for by the cost of year books. There were two print runs to catch the year books up with their respective years, \$5,501 in September 2021 and \$5,556 in December 2021.

Fees paid to Stripe amounted to \$444 during 2022, an increase of 51% from the \$220 in 2022.

The C&E accounts include the C&E Checking account and the Marshall Magruder Library Fund. The savings account was closed in 2021 due to inactivity and the balance moved to the C&E Checking account. The assets and liability and Equity are presented in the same format as the general accounts for comparison.

Other Assets are the invested funds from which annual scholarship awards are made. As in the general account, the major discrepancy is the bequest from Richard Ewell in the amount of \$80,000 in 2017 (see explanation under General Accounts).

There were multiple donations made by ACGS members in the last year:

- To the general fund:
  - received \$1,000
  - o wine at the Gathering \$250
  - the Library \$150
- To the C&E fund
  - Scholarship Fund \$650
  - o the Library Fund \$150
  - C&E Fund \$526
  - three members donated their registration costs (\$495) despite being unable to attend

The investment funds fluctuate with the market, as do the earnings. We use these funds to award scholarships to students. In 2022 we earned \$27,191, an increase of \$1,574 (6%) over the previous year. This was sufficient to make awards totaling \$30,000 to 20 recipients

#### Conclusion

Currently ACGS is financially stable, although not in a strong position. Our income relies heavily on dues with no outside body(ies) contributing.

Two years of data shows distinct trends in income depending on the time of year and whether a face-to-face Gathering has been held. Income increases in years in which a Gathering is held and declines when the Gathering is a virtual one.

#### Remembering Two MacGregors We Lost Way Too Early

My MacGregor line is a slim tree of few branches since my immigrant ancestor settled in the United States in the early 1850s. On two of these branches a pair of first cousins were causalities of World War II. On both branches they were the only sons in the family. For one he was the last of his branch of the family. Both gave their lives at a young age so that we might enjoy this society among our many freedoms today.

We never want any of our valiant members of Clan Gregor to ever be forgotten.

I never had the opportunity to meet either of these cousins or their parents as I was born years after their passing. I did get to know Raymond's younger sister, Edwina,

who was very informative about the family when I was just starting my journey of discovery into my family tree.

Raymond John MacGregor was born on Tuesday, 9 October 1917 in Port Jervis, New York to the proud parents John Samuel MacGregor and Theodora Adolphine Pieper. His paternal grandparents are John Samuel MacGregor and Anna Elizabeth Mosely. His great grandfather John McGregor emigrated from Scotland in the early 1850s and married Jane Taylor from Ireland in Manhattan, New York in 1853. Raymond is survived by his younger sister, Edwina Marie MacGregor and an older half-sister Rositta Matilda Carling.

Raymond's early years growing up were spent in the Port Jervis area and later Dingmans Township in the Pocono Mountains of northeast Pennsylvania. He graduated from Milford High School in 1934 and later attended college at Temple University's School of Commerce in Philadelphia where he graduated in 1939 with a Bachelor of Science degree in commerce. He

was one of the eight most outstanding students of his class.

At some point Raymond joined the U.S. Naval Reserves and was an Ensign at the time of his death. He received a diploma for mass formation from the Squantum Naval School in Massachusetts. He further earned another diploma for Chemical Warfare from the Edgewood Arsenal at Baltimore, Maryland.

Raymond was an authorized passenger on a routine operational training flight out of Naval Air Station Squantum in Quincy, Massachusetts. The flight took off at 2:00PM and was last heard from at 3:41PM on June 15, 1943. What exactly happened to the flight is unknown. The Navy searched both land and sea for over a month before his body was found by the dragger Mayflower near Gloucester, Massachusetts early in the week of August 15, 1943.

Raymond was buried with full military honors in the family plot in Milford Cemetery.

In 1940 Raymond's parents and sister move to Baltimore, Maryland where John went to work in the airplane industry. The family remained in Baltimore following the war where Edwina married and raised a family. Today there are still descendants residing in the area.

**Stanley Bruce Exar** was born on 11 September 1923 in Wilmington, Delaware to the proud parents Steven Stanley Exar and Edith Maude MacGregor. His maternal grandparents are John Samuel MacGregor and Anna Elizabeth Mosely. His great grandfather John McGregor emigrated from Scotland in the early 1850s and married Jane Taylor from Ireland in Manhattan, New York in 1853. Stanley was an only child.

Stanley's father emigrated from Greece in 1911 and his surname was shortened from its original Greek spelling.

Stanley's early years were spent around the Talleyville, Delaware area. He graduated from the Pierre S. DuPont High School and studied Civil Engineering at the University of Delaware where he was a member of the R.O.T.C. and swimming team. He worked for the DuPont Company at their Experimental Station. He was active with the Boy Scouts and the Talleyville Fire Company.

Stanley was called up to active duty and was an aviation machinist mate third class petty officer in the U.S. Navy. He attended basic training in

Jacksonville, Florida. Later he served in the Pacific war theatre reporting for duty in the Hawaiian Islands in the spring of 1945 following a furlough to visit his parents. Stanley was not in Hawaii long before shipping out into the battle zone. He served with the 7th Bomber Squadron assigned to the U.S.S. Currituck, a seaplane tender. His last letter home was dated 26 June 1945 in which Stanley spoke of being in the Philippines.

Stanley was only 21 when he died on July 1, 1945, from injuries received in a plane crash while in the Pacific battle area. At the time of his death Stanley was the flight engineer on a large Navy patrol bomber (seaplane). He was awarded the Purple Heart. Stanley is buried with his parents in the Grace Episcopal Church Cemetery in Brandywine Hundred (Wilmington), New Castle, Delaware.

Following Stanley's death his mother for many years was an officer in the local chapter of the Gold Star Mothers. This line of our MacGregors ended with the death of Stanley's mother Edith on 15 August 1973.

# TRUSTEES THE CHARITY AND EDUCATION (C&E) FUND

Submitted by Jack Simon, Chair

The Trustees met multiple times during the year using Zoom and Email form of communications. Discussion and action as follow:

**Financial Advisor Relationship Negotiations** were held with Merrill Lynch (ML) to form a new relationship. Formerly, ML acted as a transaction agent rather than a fiduciary representative. ML earned fees based on actual portfolio trades. Now they earn fees on portfolio performance. As a result, the advisor role has become more active and aligned with the Society's goals.

**Portfolio Performance:** the Trustees took action in Jan/Feb time frame to diversify the portfolio and invest into fixed income (preferred stock and bonds) paying 5 to 6% dividends. The rebalancing of the portfolio into fixed income changed the composition into 70% equities and 30% cash and fixed income. The net effect of this action resulted in improved cash flow and enhanced dividend returns for the C&E accounts.

**Scholarship Grants** There were 20 scholarship applications approved for grants and a total of \$30,000 awarded. This was the largest average individual award on record. The range of institutions were diverse throughout the country. Rather than mailing checks directly to the institutions, we mailed to the students with the check payee to the institution. We felt this would assist the student to avoid mishandling at the institution level.



# SCHOLARSHIP COMMITTEE

# FINANCIAL REVIEW COMMITTEE

The Financial Review Committee, for the American Clan Gregor Society, has reviewed the financial transactions of the Society for the period:

January 1, 2022 - September 30, 2022

Transactions, general ledger reports, and bank account statements for the period October 1, 2022 through December 31, 2022 were not made available to the Financial Review Committee.

As a result, the Financial Review Committee, composed of Paul O. Collinson, completed the review of financial transactions spanning the first nine months of 2022 only.

Items of concern which remain unresolved include:

The \$240 check payable to Peter Hua/Chelsea Publications (#1453) was cashed against the General account at BofA on 06/14/2022. Then in July a check for \$240 payable to Chelsea Publications (#1455) was cashed on 07/18/2022. The memo line on check #1455 reads: 'Replacement for previously sent check made out to incorrect recipient'. The Financial Review Committee did not see evidence that the \$240 from check #1453 was refunded to the Society.

The 2022 tax return for the Charity and Education Fund lists \$77,757 as 'prior year adjustments' on IRS Form 990, Part 1X, Line 24(d). Given that this is a substantial sum, the recommendation is that a clear explanation be sought by the Officers and the Trustees of the Society.

During October 2022, an informal loan was made by the Treasurer to the Society in order to expedite the opening of checking accounts with Truist. Informal loans are a highly unusual practice, particularly so when the loan involves personal funds of the Treasurer. Full repayment of the loan was reported to the Financial Review Committee.

# **COMMENTS, RECOMMENDATIONS, and REQUESTS**

The Financial Review Committee respectively submits the following comments, recommendations, and requests for consideration:

- Investment Policy Statement the Financial Review Committee makes a standing request to receive a copy of the approved Investment Policy Statement upon each update or revision. Investment Policy Statements govern the holdings and transactions within the investment accounts and state the Goals and Objectives, Risk Tolerance, and Risk Assessment.
- Transaction Sampling the transaction review spanning 01/01/2022 through 09/30/2022. Transactions, general ledger reports, and bank account statements for the period October 1, 2022 through December 31, 2022 were <u>not</u> made available to the Financial Review Committee.

The transaction review included a sampling of backup information to support transactions related to purchases, reimbursements, shipping, and to Gatherings/Games. An unresolved transaction is the \$240 check payable to Peter Hua/Chelsea Publications (#1453) which was cashed against the General account at BofA on 06/14/2022. Then in July a check for \$240 payable to Chelsea Publications (#1455) was cashed on 07/18/2022. The memo line on check #1455 reads: 'Replacement for previously sent check made out to incorrect recipient'. The Financial Review Committee did not see evidence that the \$240 from check #1453 was refunded to the Society.

An increase in the number of software subscriptions which include Adobe, Zoom, and Survey Monkey was observed. The recommendation is to consider whether or not these subscriptions are warranted.

The payment of over \$700 of interest and over \$70 of fees was paid to the Society's credit card in 2022. The recommendation is that procedures and safeguards be put in place to limit the occurrence of unpaid balances and late payment fees.

- 3. Treasurer Policy and Procedures the Financial Review Committee makes a standing request to receive a copy of the approved Treasurer P&P upon each update or revision. The Financial Review Committee further makes a standing request to receive a copy of the working draft of the Treasurer P&P at the start of each review period.
- 4. Revision of all Policy and Procedures the Financial Review Committee continues to recommend that all Policy and Procedure statements be revised to include parameters to govern spending discretion and the approval of expenses.
- 5. Professional Review/Agreed Upon Procedures the Financial Review Committee

is resolute that it is in the best interest of all concerned that a professional review/agreed upon procedures be commissioned. Benefits are numerous and include:

- -protection of Society Officers and Society Assets
- -identification of process improvements
- -identification of best business practices
- -identification of material weaknesses
- -ease of transfer in regards to future succession planning
- 6. Monthly Account Statements the Financial Review Committee recommends that electronic copies of the Bank of America bank accounts, Merrill Lynch investment account, and ACGS credit card account be delivered directly by the sending institution to the Chieftain via the chieftain@acgsus.org or as forwarded emails from the Treasurer or Trustees. This is a common practice and well worth any nominal fee that might be charged by a financial institution.
- 7. ACGS Purchases the Financial Review Committee recommends that all purchases of goods, services, and software be purchased in the name of the Society through effective use of the checking account and the credit card. Doing so effectively ensures that the Society is the owner of said assets and in full control of their use and disposition. This change would also end any need for Officers and Members to seek reimbursement for the purchase of such assets, services, and software.

The Financial Review Committee continues to note that each STRIPE transaction enters the BofA checking account with a notation that includes 'Richard Walker', the Financial Review Committee makes the recommendation that effort be made to change that notation to 'American Clan Gregor Society, Inc' and to ensure that the Society owns the STRIPE account (that a member does not own the STRIPE account).

New medallions were purchased in 2022 for \$1,150 using personal funds of a member which was then reimbursed by check by the Society. The recommendation is that goods be purchased in the name of the Society through effective use of the Society's credit card and/or checking account.

- 8. Cash Receipts In regards to the cash sale of merchandise or other cash receipts paid to the Society. The Financial Review Committee recommends that cash receipts/reimbursements continue to be converted to Stripe transactions or to paper checks. There is a nominal fee upon conversion to Stripe and a potential inconvenience/delay in regards to paper checks but these are minor in respect to the importance of creating a document trail and maintaining records of transactions. The further objective is to eliminate any instance of cash deposits or cash withdrawals.
- 9. Tax Returns The 2022 tax return for the Charity and Education Fund lists \$77,757 as 'prior year adjustments' on IRS Form 990, Part 1X, Line 24(d). Given that this is a substantial sum, the recommendation is that a clear explanation be sought by the Officers and the Trustees of the Society.

- 10. During October 2022, an informal loan was made by the Treasurer to the Society in order to expedite the opening of checking accounts with Truist. Informal loans are a highly unusual practice, particularly so when the loan involves personal funds of the Treasurer. Full repayment of the loan was reported to the Financial Review Committee.
- 11. Concentrated Positions The investment portfolio of the Society contains concentrated positions.

Two of the twelve stocks held each represent 30% of the portfolio, together these two stocks represent over 60% of the portfolio. Four of the other stocks held each make up over 5% of the portfolio, together these four stocks make up over 20% of the portfolio. The recommendation is that the Trustees amend the Investment Policy Statement to address the holding of concentrated positions and the commensurate risk. If the decision is to reduce the concentration of positions then the recommendation is to engage with and work closely with qualified professionals such as a CPA and/or a tax professional.

# A RIGHT ROYAL YEAR

The relationship between the Lord Lyon and the Monarchy in Scotland emerged from the mists of history of the Celtic kings. The forerunner of the Lord Lyon was known as the "High Sennachie" or the Royal Poet. The principal duty of the High Sennachie was to recite the genealogy of any new Monarch to prove that he was the rightful king and the rightful heir to the throne. Another role was to preside over the Inauguration of the Scottish Monarchs.

Through the course of the Middle Ages, there emerged what we now know as the Lord Lyon, King of Arms whose responsibilities included all State Ceremonial in Scotland.

I was sworn in as Lord Lyon on 14 February 2014 before the Lord President of the Court of Session. In quick succession, people kept reminding me that I was responsible for what was then known as the "Unicorn Plan" in Scotland. While that statement made little impact on me at the time, it became clear to me several years into my post that the responsibility for the arrangement of events after the death of Our Late Queen rested on my shoulders, particularly if her death should occur in Scotland. The realisation of the size and scope of the job initially caused me some panic, noting that the eyes of the whole world would be focused on our country



should The Queen die in Scotland – which turned out to be the case.

The death of a Monarch starts a whole series of ceremonial activities which culminate in the Coronation in Westminster Abbey and, in Scotland, in the presentation of the Royal Honours of Scotland to the new Monarch.

Clearly, my first duty was to create a team of people who would share the responsibility with me to make things happen and deliver the Plan in such a way as was essential to honour the Queen and for the reputation of all concerned and of our country as a whole. For several years prior to the death of The Queen, I have been working with a range of public sector partners – from Scottish Government, Police Scotland, local authorities including Edinburgh District Council and, of course, the Royal Household – in preparation for the delivery of the Scottish Plan.

As the date and place of the death of The Late Queen was of course not yet known, it was necessary to adopt a mentality of readiness for the implementation of the Plan, which included the formation of a Team Scotland to deliver the Plan. I was surrounded by supportive and talented people from throughout the public sector in Scotland, and to this day I am extremely thankful for their commitment and their expertise.


On 8 September 2022, I was called out from a lunch before the Grand Committee and the Grand Lodge of Scotland to attend at St Andrew's House what was known as the Gold Group in relation to Operation Unicorn. As I became aware that we would soon be moving into the implementation of the Unicorn Plan, my steely focus was on the need to ensure that the Plan was put into operation in such a way that was effective and followed the wishes of Her Late Majesty. We now know that Her Majesty died just after 3pm, and preparations commenced to bring her coffin from her beloved Balmoral Castle to the Palace of Holyroodhouse. It was moving to see the respects paid to the coffin along its journey from Balmoral to Edinburgh, with thousands of people lining the route who had a genuine affection for The Queen and who wished to give her a real Scottish farewell.

All of this was being managed and organised in the background and, once the Unicorn Plan had officially been put into action, it was my duty to attend the Accession Council (see right) in St James's Palace, London, on 10 September 2022 and witness the proceedings of the council.



The first act of the new King Charles III was to subscribe to the Oath relating to the security of the Church of Scotland as required by the Article 25 of the Act of Union 1707. After this act and the new King's first Proclamation was carried out at St James's Palace, I returned to make the traditional Proclamations in Scotland at the Mercat Cross and at Edinburgh Castle. I was accompanied to the Mercat Cross by my Officers of Arms, the Lord Provost of Edinburgh and the State Trumpeters. The new King was duly proclaimed and was given "Three Cheers".

Following the second Proclamation that took place in Edinburgh Castle, there were many other proclamations throughout Scotland.

The coffin of Our Late Queen was brought to the Palace of Holyroodhouse, and from there to St Giles' Cathedral for a lying at rest, during which members of the public were able to file past and pay their respects. Many from Scotland availed themselves of this opportunity. As part of the overall country's grief and respect to The Late Queen, they were joined by The King and members of the Royal Family who attended the overnight vigil.

On 12 September 2022, The King and members of the Royal family attended a Service of Thanksgiving for The Late Queen in St Giles' Cathedral, which was conducted by the Dean of the Chapel Royal in Scotland, the Very Reverend Professor David Fergusson. The Service was attended by people from all aspects of Scottish life, and in particular from organisations of which The Queen was Patron or with which she had been associated.



On 13 September, the coffin was carried out from St Giles' Cathedral and accompanied by the Princess Royal and the Dean of the Chapel Royal, was taken to Edinburgh Airport to travel in an RAF C17 aircraft to London. After the coffin left Scottish airspace, Scottish Officers of Arms and I boarded a bus for London to take

part in the processions in relation to the State Funeral in London and the services and ceremonials marking the event.

On 14 September, the Scottish Officers of Arms had the honour of preceding Her Late Majesty's coffin into Westminster Hall, and on 19 September we took part in the procession of the coffin from the



Palace of Westminster to Westminster Abbey to attend the State Funeral. Later, we all processed from the Abbey to Wellington Arch as part of the long procession in honour of The Late Queen.

As Lord Lyon, I was privileged to take part in the long walk at Windsor to St George's Chapel (see right).

The Committal Service within St George's Chapel (see below) was, for me, the most moving part of the whole ceremony, bringing the event to a conclusion and saying our farewells to Her Late Majesty.





We were no sooner back in Scotland and trying to resume our daily lives, when the issue of the Coronation became prominent in our minds, even if the announced Coronation date of 6 May 2023 still seemed a long way off.

The planning for the Coronation, known as "Operation Golden Orb", was now being increasingly talked about and prominent in our Scottish ceremonial life. I was aware that, in addition, we needed to create a further detailed plan for the Presentation of the Royal Honours of Scotland to The King in Scotland, known as "Operation Sceptre", which would take place after the Coronation.

The Court of the Lord Lyon was represented at the Coronation by myself and the Officers of Arms and by representatives of many aspects of Scottish life in Scotland. It was a magnificent occasion of celebration.

The Coronation itself was obviously the most significant event, when King Charles and Queen Camilla were officially crowned. Wide coverage was made of this and the splendid ceremonial was watched and enjoyed by millions across the world.

Prior to the Coronation, I was also heavily involved in preparing for the transport of the highly symbolic Stone of Destiny (Scone) to Westminster Abbey for its role in the

Coronation, and in ensuring subsequent safe return to Edinburgh Castle. The Stone of Destiny left Edinburgh Castle with highly specialised team and was safely delivered to Westminster Abbey on 29 April 2023. Many were involved in this operation, and it was a privilege for me as a Scot to deliver an address at the arrival and welcoming service of the Stone of Destiny into the Abbey.

I witnessed the Stone of Destiny being placed under the throne in readiness for the Coronation in ceremonial celebration of what it means to have a constitutional Monarch.



On 6 May, 2,200 people from 203 countries attended in Westminster Abbey, and The King was greeted by many state leaders as he entered the Abbey. The music for the ceremonial had been selected by The King himself.

The ceremony comprised several stages:

Stage 1: The King was presented to the people.

Stage 2: The Coronation Oath was administered to The King by the Archbishop of Canterbury.

Stage 3: For the Anointing, The King removed his ceremonial robe and sat on the Coronation Chair. This part of the ceremony was to emphasise the spiritual status of the Sovereign, who is Supreme Governor of the Church of England.

Stage 4: The Investiture of The King – this is the only time when The King wears the St Edward's Crown.

Stage 5: For the enthronement, The King was placed on his Throne above the Stone of Destiny, establishing and affirming the tradition of the Scottish connection.

In a further stage of the ceremony, Her Majesty Queen Camilla was crowned and enthroned.

As Officers of Arms of the Court of the Lord Lyon, we were honoured to witness this ceremonial and to take part in the processions out of Westminster Abbey.

Shortly before 2.30pm, the new Monarch and the Royal Family greeted the crowds in the Mall from the balcony of Buckingham Palace. This was a traditional gesture and formed part of the celebration by the whole country of the events that had taken place.

Importantly for Scotland and for myself, the final piece of this "right Royal year" was the delivery of the National Service of Thanksgiving and Dedication for Their Majesties The King and The Queen on the occasion of the Presentation of the Royal Honours of Scotland, which took place on 5 July 2023 within St Giles' Cathedral.

As part of my strong involvement and input in this Service, I was very keen to ensure that the principles which underpinned it were those that underpinned the values of Scotland. Again, this was achieved through a team of excellent, talented people who came together, many of whom had also taken part in Operation Unicorn. In my view the ceremony was not just focused on the Monarch, but also on the people of Scotland.

This same ceremony had been carried out for The Late Queen when she had visited Scotland in June 1953. In 1953, however, Scotland was a very different place from today, as there have been significant developments and changes since then which have moulded the values which underpin our modern society. One significant difference is that we now have a Scottish Parliament.

The Royal Honours of Scotland consist of a Crown (one of the oldest in Europe), a Sceptre and a Sword. The original sword was given by Pope Julius and over the years had become so fragile that it could not be used for the Ceremony. Upon the death of Queen Elizabeth, a new sword for Scotland was therefore commissioned in 2022 – the "Elizabeth Sword", which was used in the Royal Honours Ceremony. It was presented

to The King in the Palace of Holyroodhouse in advance of the service by myself together with the designer and the craftsmen and women who made the sword.



The Service and the Presentation were finalised and delivered on 5 July 2023 by representatives of Scottish life from all over the nation. The privilege and honour of leading this ceremonial and the surrounding events will remain with me for the rest of my life.

Whilst it has been an honour and privilege to be involved in the events of entire year, for my part it was the Service of Thanksgiving and Dedication and the Presentation of the Royal Honours of Scotland which will remain the highlight and the focus of my time as Lord Lyon.

The Royal Honours ceremonial was designed to focus on both our Monarch and on the people of Scotland, and on our diversity and our values. It was important for me that this be manifest in the presentation of the Crown, Sceptre and Elizabeth Sword to King Charles III.

Ihis event showed the pride of Scotland at its best and presented to The King the dynamic nature of Scottish society. There were representatives from all part of Scottish life – from the Head Boy of a Scottish school to the Lord Justice Clerk, the second highest Judge in Scotland. One highlight was the People's Procession, in which over 100 persons marched from Edinburgh Castle to St Giles' Cathedral, carefully chosen to represent the many aspects of Scottish life, our Scottish values and what it means to be a Scot.

The music before the start of the Service of Thanksgiving and Presentation, much of which was chosen and encouraged by His Majesty, demonstrated a sense of excellence and reflected the talents of Scottish society. I was honoured to take part in all the processional activity, and in particular to present the Royal Honours to The King.

At the conclusion of which I was privileged to present the Stone of Destiny:

"The presence of the Stone of Destiny or Scone in the High Kirk of Edinburgh on this occasion is a historic moment in the life of Scotland. Carved from the earth, this is a simple piece of stone. Yet, in its simplicity, it has precious and significant symbolism for the people of this land. The Stone of Destiny – An Lia Fáil – is an ancient symbol of Scottish sovereignty."

The past year or so has been a "right Royal year", and Team Scotland has been seen at its best, working together and reflecting not only our ancient traditions but also the modern life of the people of Scotland.

The Lord Lyon is wearing his MacGregor tartan for his audience with the King. Especially noteworthy.

I remember Fiona, Lady MacGregor, saying that when she was invested as Lord Lieutenant of Dumfries by the late Queen that she wore an outfit of MacGregor tartan to the ceremony. And that the Queen commented to her that she was delighted to see it, noting that nobody else getting appointments that day was wearing tartan, which was a shame.

The Royal Family have always been proud of their Scottishness and love to wear the tartan to show it. I remember King Charles visiting the Scottish Parliament shortly after becoming king. He was wearing the kilt into the chamber when he gave his speech--a gesture that was very well received by all the SNPs.

# **MAJOR GENERAL WARREN A. E. MAGRUDER**

ACGS Member number 872



Major General Magruder has been a member of the Society since 1946, but no-one knew him. At the Gathering in 2023, he was interviewed by Randy Walker and Bruce Whyte. This is a highly summarized report of that interview. Check out his membership number!!

Born in 1928 in Baltimore, MD, of working parents. He received his BSc from the University of Pennsylvania followed by MEd from the Western Maryland College. He was drafted into the army in 1950 at Camp Gordon, Georgia and served in the military police. Originally activated to go to Korea, their battalion instead made a training film on riot control.

In 1952 he participated in the early atomic tests

at Camp Desert Rock, Yucca Flats in Nevada where they monitored the effects of radiation after an atomic bomb explosion. This involved sitting in trenches behind a bunker with their backs to the explosion, wearing protective glasses and radiation measuring badges at varying distances from ground zero. This was the first and only time that troops were used in such a manner.

He had multiple positions in the years that followed: direct promotion to captain of an MP command, then Provost Marshall before joining a transportation company where he was Commander of a transportation Service Company. He had active duty as Chief of Operations and Training at the Office Chief of Army Reserve in the Pentagon. He had several more appointments at the Pentagon. In 1987 he retired as Major General Warren A. E. Magruder, Assistant Deputy Chief of Staff for Logistics, Mobilization and Training.

He had several major interests outside the Forces, American Indian beaded dress and fishing. He started fishing at age 8 in the surf at Ocean Beach and at age moved to fish the Chesapeake Bay. This led to deep sea fishing up and down the eastern US coast and the Caribbean, picking up trophies at many tournaments.

His grandfather was a doctor in Nebraska and had treated many American Indians and been paid in-kind with items of native clothing. Warren collected some of these. He was a long-time member of the Atlantic Indian Trap Shooting Association which is where he became familiar with making beaded clothing.

At the time it was legal to get golden eagle feathers from Pawnee Bill's Indian Trading Post or collect them from several sheep ranchers who could legally kill these birds. Warren used these feathers in bonnets and also took up making beaded leggings (for the technical readers, he used a squaw's lazy stitch) that required up to 20,000 beads each.

He was also inducted into the Hunkpapa Sioux tribe by none other than Frank White Buffalo Man, grandson of Chief Sitting Bull. Warren was given the Hunkpapa name of Latanka White Buffalo.

What does Warren recommend for longevity:

1 cigar a day

2 ozs Jack Daniel a day



# GRANDFATHER MOUNTAIN HIGHLAND GAMES (North Carolina)

Grandfather Mountain Highland Games (GMHG) is possibly the most iconic Scottish/Celtic Games in the country. Many of our members have visited and participated in these Games. But, many more have never been able to visit. So, this report also includes a brief history of GMHG.

Up until to the nineteenth century, North Carolina was the most prominent area of settlement for Highland Scots. Numerous Scottish immigrants moved and settled the North Carolina colony and due to the large influx of this cultural group many traditions remain there today. One such tradition is that of the Highland Games. The tradition of highland games across North Carolina is owed to the face that the Tar Heel State had the largest settlement of Highland Scots outside of Scotland until well into 1800s.

According to historian William S. Powell, today's Highland Games and cultural events "are the offshoot of ancient Celtic tests of strength and fitness, as well as competitive activities that later took place at cattle fairs, or "trysts," in Scotland". Some of the games include tossing large objects such as poles, hammers, and wheels as well as dancing, bagpipe playing, and other events. The Highland Games focus on clan gathering where those of a certain Scottish lineage reunite to compete against different families and clans.

Some of the first Highland Games emerged in the Cape Fear areas of Ellerbe and Laurel Hill in the sixteenth century. Known as "Scotch Fairs," these events were outlawed by the North Carolina General Assembly in the 1870s because of concerns over the gambling and drunken festivities that often occurred at the fairs. Yet, in the middle of the twentieth century, the Highland Games emerged once again in the North Carolina mountains.

Agnes Morton, a Linville native, and Donald F. MacDonald, a decent of the Cape Fear Highland Scots, were responsible for creating the Grandfather Highland Mountain Games in 1956. Several years earlier, MacDonald had visited Scotland in 1954. He was greatly impressed by the Braemar Highland Gathering. MacDonald wished to recreate the same festival he had witnessed in Scotland so he aligned with Agnes Morton, who had also become acquainted with the Connecticut Highland Games, and they started the first Highland Games at Grandfather Mountain on August 15, 1956. The pair chose the August 1956 date to commemorate the anniversary of an important event in the 1745 Jacobite Rebellion in Scotland, though the event was moved to the second weekend in July two years later.

William Powell claims that the present Grandfather Mountain Highland Games has grown into "the largest "clan gathering" in the world, with well over 100 clans represented each year". The games have become a four-day event held at MacRae Meadows at Grandfather Mountain. The festival opens with a torch lighting event with games, concerts, and dancing events occurring throughout the second full weekend of July. According to the mission of the Grandfather

Mountain Highland Games Inc., one of the most important aspects of the event is "to foster and restore interest in traditional dancing, piping, drumming, athletic achievement, music and Gaelic culture".

But, back to the present and the Games. AND YES, THIS IS A FOUR DAY EVENT!!

This year we had no rain, a first for many, many years. So, weather did not play any role at all.

The first day consists of children's wrestling, much entertainment, sheep dog exhibitions, clan tent setups and most importantly, Calling of the Clans that evening (we were represented by Ian Dalton). It appeared that even the heavens were welcoming the Games when the saltire was spread across the skies.



The second and third days are the busiest. They are, feeling like 18-hour days, wearing but exciting. It never ceases to surprise all of us when someone comes in and in a very meek and quiet voice states they have some documentation, but they are not sure what it means. Only to find they have brought something like a full documented tree of their family back to 800 or so. Are we MacGregors? Really? **WOW, WOW, WOW, REALLY** is the usual response

The last day starts with Kirkin' of the Tartan worship service and runs through until 5:00 pm. At that time there is an explosive "rush to wait". Visitors spend up to 3 hours waiting for bus shuttles to take them off the mountain to the parking fields below.

When we attend any Games, we prepare packets of all our handouts in advance for those visitors we feel are truly serious about finding out more about Gregor and seem likely to proceed with membership. For GMHG we usually prepare about 25-30 packets. This year we had prepared 42 but ran out of packets before lunch on Saturday. We prepared another 21 packets, using the last of our handouts, but exhausted those before lunch Sunday. Just think if only 10% followed through! We would love to see 20% (6 – 12). The most common names of visitors attending our tent were Walker (8), Gregg/Gregory (7), Greer (4), and Gregor (4).
