YUGOSLAVIA, CSCE CAN COOPERATE ONLY ON EQUAL FOOTING, SAYS SERBIAN PRESIDENT

BELGRADE, JULY 13 (TANJUG) - PRESIDENT OF THE YUGOSLAV REPUBLIC OF SERBIA S.MILOSEVIC SAID ON TUESDAY THAT COOPERATION BETWEEN YUGOSLAVIA AND THE CSCE COULD PROCEED ONLY ON AN EQUAL FOOTING, A STATEMENT RELEASED FROM THE SERBIAN PRESIDENT'S OFFICE SAID AFTER A MEETING WITH A DELEGATION OF THE EUROPEAN DEMOCRATIC UNION (EDU), AN ASSOCIATION OF EUROPEAN CHRISTIAN DEMOCRATIC, CONSERVATIVE AND KINDRED PARTIES.

'WE RESPECT THE PRINCIPLE OF UNIVERSALITY OF HUMAN RIGHTS AND FREEDOMS, AS WELL AS THE LEGITIMATE INTEREST OF THE INTERNATIONAL COMMUNITY FOR THEIR IMPLEMENTATION. IN THAT SENSE, WE ARE NOT BOTHERED BY THE PRESENCE OF CSCE MONITORS, BUT WE BELIEVE THAT (READINESS FOR) COOPERATION SHOULD BE EXPRESSED ON BOTH SIDES AND THAT EQUALITY IS THE PRINCIPLE FOR WHICH THERE CAN BE NO EXEMPTIONS, MILOSEVIC SAID.

THE EDU DELEGATION WAS TOLD THAT YUGOSLAVIA DID NOT SUSPEND A CSCE MISSION OFERATING IN ITS TERRITORY, BUT THAT ITS EIGHT-MONTH MANDATE HAD EXPIRED AND A NEW MANDATE HAD NOT BEEN NEGOTIATED. IN THAT CONTEXT, YUGOSLAVIA, AS ONE OF THE FOUNDING MEMBERS OF THE CSCE, EXPECTS THE SAME TREATMENT AS THE OTHER MEMBER STATES IN ALL CSCE BODIES, EXPLAINED MILOSEVIC.

MILOSEVIC TOLD THE EDU DELEGATION THERE WAS NO REASON TO FEAR THAT A CONFLICT MIGHT BE PROVOKED IN KOSOVO-METOHIJA BY ANY ACTION TAKEN BY THE REPUBLIC OF SERBIA BECAUSE SERBIA, JUST LIKE ANY OTHER COUNTRY, HAD NO MOTIVE AT ALL TO PROVOKE RIDTS IN ITS OWN TERRITORY. HE ALSO SAID THAT JUDGING FROM THE EXPERIENCE SO FAR, ALL CONFLICTS (IN KOSOVO) HAD BEEN EXCLUSIVELY PROVOKED BY TERRORIST GROUPS OF THE ETHNIC ALBANIAN SEPARATIST MOVEMENT. 'KOSOVO IS A PARTOF THE REPUBLIC OF SERBIA

OPEN TO ALL VISITORS. HOWEVER, ALL QUESTIONS RELATING TO ITS STATUS ARE AN INTERNAL AFFAIR OF THE REPUBLIC OF SERBIA REGULATED BY ITS CONSTITUTION, EMPHASIZED MILOSEVIC.

COMMENTING ON THE SITUATION IN BOSNIA-HERZESOVINA THE TWO SIDES AGREED THAT PROFOSALS FOR A CONFEDERAL ORGANIZATION OF THAT FORMER YUGOSLAV REPUBLIC REPRESENTED A SOLID BASIS FOR A POLITICAL SETTLEMENT WHICH A LARGE SECTION OF THE INTERNATIONAL PUBLIC HAD WELCOMED AS THE FRAMEWORK FOR REGULATING THE FUTURE RELATIONS BETWEEN THE THREE BOSNIAN COMMUNITIES. THEY ALSO SAID THEY HOPED THAT THE INTERNATIONALLY MEDIATED BOSNIA PEACE TALKS WOULD RESUME AS SOON AS POSSIBLE.

BOSNIA - HERZEGOVINA

MOSLEMS RESPONSIBLE FOR ATTACK ON SARAJEVO CIVILIANS, SAY BOSNIAN SERBS

BELGRADE, JULY 13 (TANJUG) - THE BOSNIAN SERB ARMY COMMAND ON TUESDAY REJECTED ANY RESPONSIBILITY FOR A MORTAR ATTACK ON THE SARAJEVO DISTRICT OF DOBRINJA ON MONDAY AFTERNOON AND SAID IT WAS CARRIED OUT BY MOSLEM TROOPS STATIONED ON MT IGMAN.

ACCORDING TO AGENCY REPORTS ON MONDAY, 12 PEOPLE WERE KILLED AND 15 WOUNDED WHEN A MORTAR SHELL SLAMMED INTO A CROWD WAITING FOR WATER IN DOBRINJA.

EXPRESSING INDIGNATION OVER THE ATTACK, THE BOSNIAN SERB ARMY COMMAND SAID IN A STATEMENT THAT THE MASSACRE WAS THE RESULT OF AN INSANE AND TRANSPARENT POLICY PURSUED BY THE MOSLEM LEADERSHIP WHICH DID NOT HESITATE TO SACRIFY INNOCENT CIVILIANS IN SARAJEVO IN ORDER TO AVOID TALKS AND BLAME THE INCIDENT ON THE SERBS.

HVO OFFICER SAYS CROATS WILL LIBERATE ALL THEIR TERRITORIES IN CENTRAL BOSNIA

BELGRADE, JULY 13 (TANJUG) - COL. TIHOMIR VLASKIC OF THE CROATIAN DEFENSE COUNCIL (HVO) SAID TUESDAY THE HVO FORCES IN CENTRAL BOSNIA WERE PREPARING TO LIBERATE IN THE COMING DAYS ALL CROATIAN SETTLEMENTS AND TERRITORIES WHICH THE MOSLEM ARMY HAS OCCUPIED, CROATIAN RADIO REPORTED.

COL. VLASKIC TOLD A PRESS CONFERENCE IN BUSOVACA, CENTRAL BOSNIA, THERE WAS NO SECRET ACCORD OR AGREEMENT BETWEEN THE HVO AND THE BOSNIAN SERB ARMY, BUT THAT THE MOSLEM ARMY WAS FLOUTING THE CEASEFIRE ACCORD THE MILITARY COMMANDERS OF ALL THREE ETHNIC COMMUNITIES IN BOSNIA HAD SIGNED IN SARAJEVO ON MAY 12.

CROATIAN RADIO HAS REPORTED VICE-PRESIDENT OF THE CROATIAN COMMUNITY OF HERZEG-BOSNIA D.KORDIC AS TELLING NEWSMEN THAT AFTER THE ATTACKS AND CRIMES BY THE MOSLEM ARMY IN CENTRAL BOSNIA, BOSNIA-HERZEGOVINA COULD ONLY EXIST AS A CONFEDERATION.

JUPPE SAYS PRESSURE TO BE PUT ON ALL THREE SIDES IN BOSNIA

BUDAPEST, JULY 13 (TANJUG) - FRENCH FOREIGN MINISTER A.JUPFE SAID TUESDAY THE INTERNATIONAL COMMUNITY MUST CONTINUE PRESSURE ON ALL THREE WARRING SIDES IN BOSNIA UNTIL THEY OPTED FOR A PEACEFUL SOLUTION. JUPPE SAID THE SANCTIONS AGAINST THE F.R.Y. WOULD BE IN FORCE 'AS LONG AS

A PEACEFUL SOLUTION IN BOSNIA IS NOT FOUND', AND MADE A CLEAR WARNING TO CROATIA THAT IT, TOO, WOULD EXPERIENCE AN INTERNATIONAL EMBARGO. 'THE BOSNIAN MOSLEMS, AS WELL, MUST BE CAUTIONED THEY, TOO, MUST OPT FOR A PEACEFUL SOLUTION, 'JUPPE SAID.

JUPPE STATED REGRET THAT THE FRENCH INITIATIVE CONCERNING 'SAFE AREAS' FOR MOSLEMS IN BOSNIA HAS AT THIS TIME REMAINED AT CONCEPT LEVEL, BECAUSE, AS HE SAID, IT REQUIRED COMPLEX PREPARATIONS AS AN ESTIMATED 70,000 TROOPS WERE NEEDED FOR ITS IMPLEMENTATION.

STOLTENBERG HOPES GENEVA TALKS ON BOSNIA TO RESUME BY END OF WEEK
WASHINGTON, JULY 13 (TANJUG) - INTERNATIONAL MEDIATOR FOR
YUGOSLAVIA T.STOLTENBERG STATED THE HOPE THAT THE NEXT ROUND OF TALKS
BETWEEN THE THREE SIDES IN BOSNIA WOULD BEGIN IN GENEVA BY THE END OF
THE WEEK, AND THAT ALL THREE PARTIES HAVE PROMISED TO ATTEND.

HE CATEGORICALLY DENIED CLAIMS HE 'THREATENED' THE MOSLEM SIDE THE U.N. WOULD PULL OUT OF BOSNIA UNLESS THE PEACE TALKS CONTINUED. HE SAID HE NEVER LINKED THE TWO ISSUES AND THAT IT SHOULD BE CLEAR THAT IF ONE SIDE REFUSED TO NEGOTIATE THE U.N. WOULD CONTINUE REGARDLESS OF THE TALKS TO WORK ON ENHANCING THE PRESENCE OF THE U.N. AS WELL AS THE HUMANITARIAN EFFORT IN BOSNIA.

HOWEVER, HE NOTED IN AN INTERVIEW TO THE U.S. CNN TV THERE WERE CONSIDERABLE PROBLEMS IN THE WAY OF THE U.N. FULFILLING ITS MANDATE IN CONDITIONS OF A HIGH SECURITY RISK. HE STRESSED HE SINGLED OUT THE TWO CRITICAL POINTS: SECURITY OF U.N. PERSONNEL AND THE DRAMATIC SITUATION REGARDING HUMANITARIAN AID IN HIS REPORT TO THE U.N. SECURITY COUNCIL.

ASKED WHETHER THIS IN IT SELF WAS NOT A SORT OF PRESSURE, STOLTENBERG REPLIED THAT THIS WAS SO, BUT IN THE WAY OF FULFILLING THE U.N. MANDATE.

ASKED HOW HE THOUGHT HE WOULD GO ABOUT SECURING THE ACCEPTANCE OF THE MOSLEM SIDE FOR ETHNIC PARTITION OF BOSNIA UNDER THE PRESENT CONDITIONS, HE ANSWERED THAT AT THIS TIME THE MOST IMPORTANT THING WAS TO SIT AT THE NEGOTIATING TABLE AND EXAMINE WHAT KIND OF AN ACCORD WAS POSSIBLE BECAUSE, AS HE NOTED, ONE MUST NOT RULE OUT THE POSSIBILITY AN ACCORD THAT WOULD SATISFY ALL SIDES, INCLUDING THE MOSLEM MAY BE REACHED. STOLTENBERG EMPHASIZED THAT NEGOTIATIONS HAD NO ALTERNATIVE.

SPEAKING ABOUT THE PLANES THE PENTAGON HAS ADDITIONALLY SENDING (TO ITALY) FOR PROTECTION OF UNPROFOR IN BOSNIA AND THE POSSIBILITY OF INTERVENTION IF THEY WERE PROVOKED, STOLTENBERG SAID ONE SHOULD FOCUS AT THIS TIME ON THE PEACE PROCESS AND THAT THERE WAS NO NEED FOR SUCH ACTION NOW.

THE R.S.K. (UNPA)

CROATIA HASTILY PREPARING TO ATTACK REPUBLIC OF SERB KRAJINA
BELGRADE, JULY 13 (TANJUG) - CROATIA IS HASTILY PREPARING TO
ATTACK THE R.S.K., THE RSK FOREIGN MINISTRY SAID ON TUESDAY. MINISTER
S.JARCEVIC SAID IN A STATEMENT THAT A CROATIAN ASSAULT MIGHT BE
ATTEMPTED AROUND AUGUST 1, A MONTH AFTER THE RENEWED MANDATE OF THE
UNPROFOR HAD EXPIRED. CROATIAN AUTHORITIES ARE ALREADY TRYING TOCONVINCE THE WORLD PUBLIC THAT UNPROFOR'S MANDATE WILL NOT BE EXTENDED
BECAUSE OF LACK OF COOPERATION ON THE RSK SIDE, SAID JARCEVIC.

THE RSK FOREIGN MINISTRY STATEMENT ALSO SAID THAT CROATIA

ATTACHED GREAT IMPORTANCE TO THE CONSTRUCTION OF A PONTOON BRIDGE OVER THE MASLENICA CHANNEL, WHICH IT CAPTURED IN THE JANUARY OFFENSIVE, AND THAT THE ENTIRE DIPLOMATIC CORPS FROM ZAGREB WAS INVITED TO ATTEND ITS INAUGURATION.

THE MINISTRY SAID THAT THE CROATIAN ATTACK ON BENKOVAC AND ITS BURROUNDINGS ON TUESDAY AND MOVEMENTS OF CROATIAN TROOPS TOWARDS LIKA IN THE SOUTH-WEST OF THE RSK CONFIRMED REPORTS ABOUT CROATIA'S HASTY PREPARATIONS FOR THE OFFENSIVE ON THE RSK.

DUE TO SANCTIONS

NINE OUT OF EVERY TEN YUGOSLAV COMPANIES STOPPED WORK IN MAY
BELGRADE, JULY 13 (TANJUG) - THE PRODUCTION OF 92 PERCENT OF
COMPANIES CAME TO A STANDSTILL IN MAY DUE TO LACK OF RAW MATERIALS AND
MANUFACTURING COMPONENTS, T.MILISAVLJEVIC, MANAGER OF THE MARKET
RESEARCH INSTITUE IN BELGRADE SAID ON THE BASIS OF A POLL CONDUCTED IN
200 COMPANIES THROUGHOUT YUGOSLAVIA.

INDUSTRIAL PRODUCTION IN MAY WENT 7.3 PERCENT DOWN FROM APRIL, AND 46 PERCENT FROM THE SAME MONTH LAST YEAR. THE DECREASE OF PRODUCTION WAS CAUSED BOTH BY SHORT SUPPLIES OF PRODUCTION MATERIALS AND BY LOW DEMAND. THE POLL SHOWED THAT 66 PERCENT OF THE COMPANIES LACKED A SUFFICIENT NUMBER OF ORDERS TO WORK AT FULL CAPACITY. THE YUGOSLAV INDUSTRY, LARGELY EXPORT AND IMPORT-ORIENTED, HAS BEEN COMPLETELY SEVERED FROM THE FOREIGN MARKETS FOR THE LAST 14 MONTHS, MILISAVLJEVIC SAID.

52 PERCENT OF THE COMPANIES IN WHICH THE POLL WAS CONDUCTED, EXPECT REDUCED TURNOVER IN THE COMING THREE MONTHS.

NATIONAL INCOME OF SERBIA AND MONTENEGRO, THE TWO YUGOSLAV REPUBLICS, WAS REDUCED FROM 3,000 U.S. DOLLARS IN 1990 TO 1,600-1,700 DOLLARS IN 1992. EXPERTS ESTIMATE THAT IT WILL AMOUNT TO 600 DOLLARS AT THE END OF 1993, UNLESS THE SANCTIONS ARE EASED BY THE INTERNATIONAL COMMUNITY.

MEDICAMENTS IN SHORT SUPPLY IN SERBIA, SITUATION DRAMATIC

BELGRADE, JULY 13 (TANJUG) - SHORTAGES OF MEDICAMENTS IN THE YUGOSLAV REPUBLIC OF SERBIA, WHICH HAVE BECOME DRAMATIC OVER THE PAST MONTH, THREATEN THE LIVES OF PATIENTS SUFFERING FROM CHRONIC DISEASES, SHOWS A SURVEY CONDUCTED BY TANJUG. PRODUCERS SAY THE MAIN REASON FOR REDUCING THEIR DELIVERIES OF MEDICAMENTS OR STOPPING THEM ALTOGETHER IS THE LACK OF SOME RAW MATERIALS WHICH ARE NORMALLY IMPORTED.

ALTHOUGH MEDICAMENTS AND FUNDS FOR PURCHASING MEDICAL SUPPLIES ABROAD ARE EXEMPTED FROM THE SANCTIONS IMPOSED AGAINST THE F.R.Y. UNDER U.N. SECURITY COUNCIL RESOLUTION 757 THE ISSUING OF PERMITS FOR EXPORTS TO YUGOSLAVIA IS BEING CONSTANTLY DELAYED, SAID B.VUKOVIC, PRESIDENT OF THE YUGOSLAV GOVERNMENT COMMITTING IN CHARGE OF FOLLOWING THE EFFECTS OF THE SANCTIONS.

YUGOSLAV PRIME MINISTER R.KONTIC ON FRIDAY SAID THAT THE U.S. WAS BEHIND THE INTERNATIONAL COMMUNITY'S DECISION NOT TO ALLOW IMPORTS OF PHARMACEUTICAL RAW MATERIALS IN YUGOSLAVIA. 'THE U.S. DOES NOT ALLOW IMPORTS OF RAW MATERIALS KNOWING THAT IT WOULD FORCE US TO IMPORT

MEDICAMENTS, WHICH WOULD EXHAUST THE COUNTRY'S ALREADY SCARCE FOREIGN CURRENCY RESERVES, HE SAID.

SHORTAGES OF MEDICAMENTS ALSO RESULT FROM THEIR VERY HIGH PRICES. THE GOVERNMENT APPROVED THE LATEST PRICE RISE MORE THAN A MONTH AGO ALTHOUGH THE PHARMACEUTICAL INDUSTRY PAYS FOR RAW MATERIALS IN FOREIGN CURRENCIES, WHOSE EXCHANGE RATES RISE A FEW PERCENT DAILY. THUS, BY SELLING MEDICAMENTS AT LOW PRICES THE PHARMACEUTICAL INDUSTRY MAKES LOSSES.

STATE-OWNED PHARMACIES IN SERBIA'S SOUTHERN PROVINCE OF KOSOVO-METOHIJA RECEIVED NO MEDICAMENTS AT ALL IN THE PAST TWO WEEKS, SAID LJ.CVETKOVIC, DIRECTOR OF THE PRISTINA FIRM FARMED, THE PROVINCE'S ONLY SUPPLIER.

SURGICAL MATERIALS ARE ALSO IN SHORT SUPPLY AND DOCTORS OPERATEONLY IN CASES OF EMERGENCY.

YUGOSLAV DOCTORS HAVE REPEATEDLY WARNED THAT THE IMPLEMENTATION OF THE ECONOMIC SANCTIONS, IMPOSED ON JUNE 30 LAST YEAR, ARE SERIOUSLY THREATENING THE LIVES AND HEALTH OF CIVILIANS IN YUGOSLAVIA AND PARALISING THE NORMAL FUNCTIONING OF HOSPITALS AND THE PHARMACEUTICAL INDUSTRY.

OPINIONS

NO SERBIAN GOVERNMENT WILL AGREE TO 'INDEPENDENT' KOSOVO

PARIS, JULY 13 (TANJUS) - FORMER CO-CHAIRMAN OF THE CONFERENCE ON THE FORMER YUGOSLAVIA LORD CARRINGTON MAINTAINS THAT NO SERBIAN GOVERNMENT, AT PRESENT OR IN FUTURE, WILL AGREE TO 'IDEPENDENT' KOSOVO. LORD CARRINGTON, IN AN INTERVIEW FUBLISHED BY THE FRENCH DAILY EXTERMED ON TUESDAY, SAID THE SPREADING OF THE CONFLICT TO SERBIA'S SOUTHERN PROVINCE COULD BE AVERTED.

THE UNITED NATIONS AND THE INTERNATIONAL COMMUNITY ARE TO INSIST ON THE OBSERVANCE OF HUMAN RIGHTS IN KOSOVO, ACCORDING TO LORD CARRINGTON.

LORD CARRINGTON DISCUSSED THE ETHNIC CONFLICT BETWEEN MOSLEMS, SERBS AND CROATS IN BOSNIA-HERZEGOVINA AND SAID A SOLUTION ACCEPTABLE TO ALL THREE SIDES MUST BE FOUND FOR THE FORMER YUGOSLAV REPUBLIC. HE MAINTAINS THAT BOSNIAN CROATS WILL EVENTUALLY JOIN CROATIA AND BOSNIAN SERBS SERBIA, WHILE A STATE WOULD BE FORMED FOR BOSNIAN MOSLEMS.

THE PREMATURE RECOGNITION OF THE FORMER YUGOSLAV REPUBLICS OF SLOVENIA, CROATIA AND BOSNIA-HERZEGOVINA WAS A BIG MISTAKE OF THE INTERNATIONAL COMMUNITY, ACCORDING TO LORD CARRINGTON. HE SAID HE HAD WARNED EUROPEAN LEADERS THAT, BY RECOGNIZING THE REPUBLICS, THEY WOULD DESTROY ALL PEACE EFFORTS AND ADDED THAT THEY LISTENED TO HIM, BUT DID NOT HEAR HIM.

VIOLATIONS OF THE NO-FLY ZONE OVER BOSNIA

BOUTROS-GHALI: MOSLEMS AND CROATS VIOLATED THE NO-FLY ZONE OVER BOSNIA-HERZEGOVINA

NEW YORK, JULY 13 (TANJUG) - BOSNIAN MOSLEMS AND CROATS HAVE VIOLATED THE NO-FLY ZONE OVER BOSNIA-HERZEGOVINA NINE TIMES IN ONLY TWO DAYS (JULY 5-7), IT WAS SAID IN A NOTE SENT BY U.N. SECRETARY GENERAL B.GHALI TO THE CHAIRMAN OF THE U.N. SECURITY COUNCIL. DURING THE

MENTIONED PERIOD (JULY 5-7) HELICOPTERS OF THE MOSLEM GOVERNMENT IN SARAJEVO HAVE VIOLATED THE NO-FLY ZONE EIGHT TIMES AND A FLIGHT OF A CROATIAN AIR FORCE WAS REGISTERED ONCE, IT WAS SAID IN THE NOTE SENT ON JULY 8.

B.GHALI ENCLOSED A DETAILED UNPROFOR REPORT WHICH SAYS THAT ALL THE VIOLATIONS WERE REGISTERED IN THE AREAS UNDER MOSLEM ARMY CONTROL, MAINLY IN THE REGION OF TUZLA IN NORTHEASTERN BOSNIA-HERZEGOVINA.

IN ONE CASE, FOR EXAMPLE, ON JULY 5 A MOSLEM ARMY 'M-8' HELICOPTER TOOK OFF FROM THE DUBRAVA AIRPORT NEAR TUZLA IN FRONT U.N. MILITARY OBSERVERS WHO WERE PRESENT, IT WAS SAID IN THE REPORT.

NATO PILOTS HAVE REGISTERED A HELICOPTER FLIGHT 26 KM SOUTHEAST OF TUZLA ON JULY 7. OVER 100 PEOPLE WERE NOTICED BY THE HELICOPTER ONCE IT LANDED, IT WAS SAID IN THE REPORT.

A CROATIAN HELICOPTER VIOLATED THE NO-FLY ZONE FLYING FROM SPLIT, A CROATIAN CITY ON THE ADRIATIC COATS, TO VITEZ, A CITY IN CENTRAL BOSNIA-HERZEGOVINA WHERE FIERCE FIGHTING HAS BEEN TAKING PLACE BETWEEN MOSLEMS AND CROATS IN THE LAST FEW MONTHS.

BOSNIAN SERB ARMY PROTESTS NO-FLY ZONE VIOLATIONS

BELGRADE, JULY 13 (TANJUG) - THE GENERAL STAFF OF THE BOSNIAN SERB ARMY (V.R.S.) PROTESTED TO UNPROFOR COMMANDER FOR FORMER YUGOSLAVIA GEN.J.COT BECAUSE ALMOST DAILY MOSLEM AND CROATIAN HELICOPTERS OR AIRPLANES IN VIOLATION OF THE NO-FLY ZONE BREACHED THE U.N. SECURITY COUNCIL RESOLUTION 816, BANNING FLIGHTS OVER BOSNIA-HERZEGOVINA.

A STRONG PROTEST IS VOICED OVER THESE INCIDENTS AND HOPE STATED THAT THE NATO AIR FORCE, ENGAGED IN MONITORING THE NO-FLY ZONE OPERATION, WAS NOT UNDERTAKING ADEQUATE MEASURES TO CONSISTENTLY IMPLEMENT THE U.N. SECURITY COUNCIL RESOLUTION.

THE PROTEST SAID THAT ON TUESDAY ALONE, THERE WERE FOUR FLIGHTS IN VIOLATION OF THE BAN, AND SPECIFIED THE ROUTES AND ACTIVITIES OF THE MOSLEM AIRCRAFT FROM THE TUZLA AIRPORT.

THE V.R.S. GENERAL STAFF ASKED GEN. COT TO INFORM THE SECURITY COUNCIL AND THE U.N. SECRETARY-GENERAL ABOUT THE INCIDENTS AND TO MOST STRONGLY WARN THE MOSLEM AND THE CROATS SIDES. OTHERWISE, AS SET OUT, RESOLUTE MEASURES TO PROTECT THE SERB TERRITORIES WOULD HAVE TO BE TAKEN, SAID THE V.R.S. GENERAL STAFF STATEMENT, SIGNED BY ITS HEAD, GEN.M.MILOVANOVIC.

UNPROFOR

ARMS FOUND IN CROATIA-BOUND UNPROFOR CONVOY

TOPUSKO, JULY 13 (TANJUG) - THE AUTHORITIES OF THE R.S.K. HAVE STOPPED MONDAY NIGHT A TEN-TRUCK UNPROFOR CONVOY BOUND FOR THE FORMER YUGOSLAV REPUBLIC OF CROATIA AFTERROUTINE CONTROL TURNED OUT IT CARRIED 40 TONNES OF AMMUNITION AND ANTI-ARMOR HAND GRENADES, TANJUG CORRESPONDENT HAS LEARNED FOR THE R.S.K. SOURCES. THE CONVOY WAS NOW AT THE NEUTRAL ZONE AT A PLACE CALLED TURANJ ON THE CROSSING FROM THE R.S.K. TO CROATIA.

MEMBERS OF THE POLISH UNPROFOR BATTALION, ESCORTING THE CONVOY, SAID THE ARMS WERE BEING TRANSPORTED FOR THE NEEDS OF UNPROFOR, BUT THE R.S.K. BORDER AUTHORITIES SAID AN ATTEMPT HAD BEEN MADE TO TRANSPORT THE

ARMS WITHOUT THE NECESSARY DOCUMENTATION AND PERMISSION OF THE R.S.K. AUTHORITIES AND THAT THE CARGO CONTAINED ANTI-ARMOR GRENADES, WHICH UNPROFOR MEMBERS ARE NOT PERMITTED TO USE. UNPROFOR OFFICIALS WERE ASKED FOR AN EXPLANATION, BUT IN THE MEANTIME, THE FOLES, REVOLTED WITH THE BAN TO ENTER CROATIA, 'RESPONDED' BY POSITIONING TWO ARMORED PERSONNEL CARRIERS AT THE TURNAJ BORDER-CROSSING, WHICH CAUSED ADDITIONAL TENSION.

GERMANY CAN INFLUENCE CROATIAN POLICY

BONN, JULY 13 (TANJUG) - GERMAN CHANCELLOR H.KOHL AND HIS GOVERNMENT CAN UNDOUBTEDLY INFLUENCE THE POLICY OF THE FORCIBLY SECEDED FORMER YUGOSLAV REPUBLIC OF CROATIA, UNDER THE CONDITION THAT THEY HAVE A POLITICAL CONCEPT, BERLIN DAILVIELE ABAGINETING WROTE ON TUESDAY.

DIE TAGESZEITUG'S VIEW IS THAT BONN DOES NOT YET LIVE UP TO GIVING ADVICE, THAT GERMANY RECOGNIZED CROATIA AND SLOVENIA TOO EARLY AND BEFORE IT OFFERED A SAFE POLITICAL SOLUTION. TO RECOGNIZE TWO REPUBLICS IN THE DISINTEGRATING YUGOSLAVIA, AMID THE BALKANS POWDER KEG WITHOUT ENVISAGING THE FRAME OF THE FUTURE STABILITY IN THE REGION, EQUALS CRIMINAL FOREIGN POLICY RECKLESSNESS, DIE TAGESZEITUNG CONCLUDED.

THERE IS NO AUTHORITY IN BOSNIA-HERZEGOVINA, SAYS DEFENCE MINISTER

Z A G R E B, JULY 13 (TANJUG) - 'THERE IS, INDEED, OBJECTIVELY NEITHER A GOVERNMENT NOR A PRESIDENCY OF THE STATE, DEFENCE MINISTER IN BOSNIA-HERZEGOVINA'S PRO-MOSLEM GOVERNMENT B. RAJIC HAS TOLD THE ZAGREB DAILY WIRSHUMK. THEY ARE LEGITIMATE 'ONLY BECAUSE, APART FROM MOSLEMS, CROATS PARTICIPATE IN THEIR WORK, SAID BOSNIAN CROAT RAJIC.

THE AUTHORITY IS, IN FACT, HELD BY MOSLEMS BECAUSE, ACCORDING TO RAJIC, THEIR CADRES ARE INTERPRETING THE REALITY IN BOSNIA-HERZEGOVINA, WHERE A CIVIL AND ETHNIC WAR HAS BEEN RAGING FOR OVER 15 MONTHS. 'THERE IS ACTUALLY NO AUTHORITY IN BOSNIA-HERZEGOVINA, WHICH SHOWS THAT THE STATE, SUCH AS IT IS NOW, CANNOT AND SHOULD NOT LIVE, 'RAJIC SAID.

IF BOSNIA-HERZEGOVINA DISAPPEARS AS A STATE, MOSLEM POLITICIANS WILL BE RESPONSIBLE, RAJIC SAID.

AMBIGUOUS DECISIONS MADE BY DIVIDED BIH PRESIDENCY

ZAGREBY 13 (TANJUG) - MEMBERS OF THE COLLECTIVE PRESIDENCY OF BOSNIA-HERZEGOVINA, WITH THEIR AMBIGUOUS DECISIONS, HESITATION AND DISCORD, DO NOT AT ALL HELP AN EXIT BE FOUND FROM THE TERRIBLE WAR, WRITES THE ZAGREBY DAILY ON TUESDAY.

VJESNIK WRITES THAT THE LATEST TWO-DAY SESSION OF THE BIH PRESIDENCY, HELD IN ZAGREB LAST WEEKEND, ONLY SHOWED ITS CONFUSION AND ALMOST DIRECT BLAME FOR A GOOD PART OF TROUBLE BE FALLING THE POPULATION OF THE BIH.

AT FIRST IT HAD BEEN MADE PUBLIC THAT THE BIH PRESIDENCY WOULD ACCEPT 'A CONFEDERAL ORGANIZATION' OF THE BIH, LATER IT WAS DECIDED TO DISCUSS ONLY THE PRINCIPLES, NOT THE SPECIFIC FORMS OF STATE

ORGANIZATION, AND THEN, AT THE CLOSE OF THE SESSION, IT WAS PROPOSED TO CONSIDER A FEDERAL ORGANIZATION OF THE BIH AND CALL ONE MORE ROUND OF TALKS.

THIS IS HOW 'THE STATE HELMSMEN,' WRITES VJESNIK, WASTE TIME, MONEY AND HUMAN LIVES, BECAUSE, WHILE THEY WONDER WHAT IS TO BE DONE AND HOW, THE RAVAGING WAR GOES ON.
