Dear Mr. Haller:

Thank you for your recent letter with regard to the current situation in Haiti. I appreciate learning of your views on this important matter.

I believe that the current U.S. policy towards Haiti, including economic sanctions, needs to be reassessed. I realize that the United Nations Security Council has voted to expand economic sanctions against Haiti and has voted, at the urging of the United States, in favor of using "all means necessary" to encourage the current military leadership to step down. I understand that the aim of tighter sanctions is to force the current military leaders of Haiti, who came to power by an illegitimate coup, to step aside and allow President Aristide to return to his country, as the Haitian military agreed when it signed the Governors Island Accord last year.

I am concerned, however, that economic sanctions have their greatest impact on the already impoverished Haitian people and the failing Haitian economy. The sanctions should be retargeted to penalize with maximum impact those who have seized and abused power. More broadly, I believe we should focus on three key goals regarding Haiti:

- 1) alleviate the suffering of the Haitian people;
- 2) prevent massive Haitian emigration to the United States; and
- 3) shift our near-term policy focus away from restoring democracy via Aristide's return to one of building democracy by consensus and vitalizing political and economic structures in Haiti, with Aristide's return deferred until this process takes hold.

I am hopeful that the United States can advance these goals without having to resort to the use of force. However, as the President has stated, we cannot rule out this possibility and

must have a carefully thought-through strategy for fostering democracy while our forces are in Haiti; as well as for withdrawing our forces from Haiti.

Please be assured that when the Senate reviews our policy towards Haiti, I will keep your comments in mind.
