Dear Mr. President:

Many Serbian-Americans are very disturbed to see the rioting scenes taking place in Belgrade today, and hope that a peaceful resolution can be achieved immediately.

I regret that I did not write you earlier in the week as I had intended to do, urging you to open up your media so that every side can be presented to the public. Using force on issues that involve freedom of speech or press cannot survive in this day and age in any part of the world. I would not want to see a most difficult situation made worse because of a refusal by you and/or your people to be willing to compromise or deal with the opposition.

As one who worked in the media for twenty-five years and who, these days, is a subject of the media, I have found that openness works the best for all concerned.

Please consider changing your position because by opening up your press, you would become the true pacesetter in Yugoslavia as the most democratic of all of the Republics. I urge you to think seriously about this opportunity.

If I am able to help in any way bridging this situation between you and others, I would be very happy to come over now rather than wait until March 24, with the Helsinki Commission. Since I have served successfully as the mediator in several tough labor disputes, I have the necessary experience with the interest of Serbia at heart.

I am sure that you realize my concern these days is for Serbia to come out on top. I am convinced that if you will pull back, not only would everything calm down, but your support would be improved and any criticism substantially eased.

Dear Mr. President:

Considering that we both work for the betterment of the Serbian people, I hope you won't mind sharing some of my recent thoughts about the problems with which the Serbian nation is faced at this time.

I am sure you know how extremely concerned Serbian-Americans are about everything that is happening to Serbians in Yugoslavia at the present moment. Daily reports on the continued armed confrontations in the Serbian parts of Croatia, on Serbian homes being demolished and stores banned with increasing numbers of Serbian refugees, make us more and more worried about the prospect of a potential full-scale civil war in Croatia and possibly on a second front in Kosovo.

I am constantly monitoring the Yugoslav crisis hoping that my limited efforts on behalf of the Serbian people will help ensure that history does not repeat itself. Last week at a Serbian rally in Chicago I and other participants expressed disappointment with the negative public opinion toward Serbians. We also called on the U.S. citizens not to forget that Serbia always has been an ally to the United States, particularly during World Wars I and II, as well as a friend for many, many decades.

It is very discouraging to see the extent to which public opinion in the U.S. has become anti-Serbian because of a constant press hammering of communism leadership in Belgrade.

As far as the U.S. Congress is concerned, you may be aware that Congressman Tom Lantos, California, again has introduced a resolution which expresses support for the Yugoslav secessionist republics and calls for cut-off of all direct assistance to Yugoslavia, while blaming Serbia for not responding to calls for negotiations leading to a peaceful settlement of the Yugoslav crisis.

Considering the fact that we have to obtain much more support in order to defend Serbian interests, I have been endeavoring to determine what could be the best strategy to make Serbia's potential friends and allies more involved in their cause. Many of my colleagues and Serbian-American friends believe it would be much easier to continue our fight for the Serbian voice to be heard, if the American public could see something new happening in Serbia today, so the communist myth could be dismissed once and for all.

We think that if Americans could see how Serbia is progressing on the path of reforms which it initiated a few years ago in Yugoslavia, they rapidly would change their present negative approach to the problems with which the Serbian nation is faced. It is believed that if some new, prominent public figures would be brought to key positions in your Administration, these aims could be achieved. A real coalition government would be a tremendous boost.

Of course, your position enables you to see much better than I can the possible changes your government could implement in order to obtain the needed support.

Rest assured that I will continue with my efforts to defeat measures that could harm the Serbian people but we need help with some positive moves from Serbia.

Thank you for sharing these thoughts with me.

This is vital if Serbia is not to isolate itself completely from the rest of the international community, and if there is to be a comprehensive settlement to the current crisis that will address the concerns of the Republic of Serbia.

In addition, I would urge you to use caution in any official recognition of either Serbs in Croatia or Bosnia. This is a two-edged sword, and would force international recognition of the province of Kosovo as an independent republic.

Please realize Serbia's precarious situation vis-a-vis the international community and do all in your power to facilitate a peaceful solution to the current crisis.

Dear Mr. President:

I have given your desire to visit Washington much thought. To be frank, however, I must say that after consulting with a number of key people in Washington power circles, there is still resistance to meetings with you.

Although Serbia is backing the Vance peace plan, which definitely is a positive step in salvaging Serbia's international reputation, Serbia is unfortunately still perceived in the west as a "Bolshevik" or "Communist" state. The individuals with whom I spoke expressed reluctance to your visit because they did not want to be connected with a regime that could be considered even partially totalitarian.

The recent Helsinki Watch reports also went far in exposing problems with both the Serbian and Croatian governments. Now, at least, the Croatian regime does not appear as "innocent" as its proponents have espoused for the last year. However, the reports also exposed some continuing concerns that the west has with the record of human rights in Serbia.

I would strongly urge you to do the following to bolster Serbia's international reputation:

- 1. Publicly denounce communism and any desire to return to communism after the cessation of hostilities.
- Remove the red star from official use on flags, uniforms, vehicles, or any other equipment used in an official capacity by the Republic of Serbia, and Yugoslavia if possible.
 - 3. Remove any and all restrictions on the press.
- 4. Return Shayna Lazarevich's children to their mother. Every court In the U.S. and Serbia has upheld her right to custody.

I realize that lifting press restrictions in Serbia may be undesirable for you, but I believe that it is vital, and that it will have a positive effect in the long run. One of the most, if not the most visible, sign of a true democracy is a free press, with both the good and the bad that comes with it.

I am coming under increasing fire from Congress and from the American public, as are some of my other colleagues, for supporting a country that is considered the last bastion of communism in Europe. These few steps would go far in defusing current critisism and reassuring the west that democratic reform is continuing in the Republic of Serbia.

At the same time I want to assure you we understand that Serbia is ahead of Croatia in the so called free-market economy. However, the perception of a "communist" Serbia is still so strong that that is all people focus on.

AT THE INITIATIVE OF PATRIARCH PAVLE, A CONFERENCE WAS TO BE HELD IN SARAJEVO OF THE RELIGIOUS LEADERS OF THE THREE MAJOR RELIGIOUS COMMUNITIES IN YUGOSLAVIA CATHOLICS, MOSLEMS AND ORTHODOX CHRISTIANS. PATRIARCH PAVLE WAS COMPELLED TO POSTPONE THE CONFERENCE DUE TO AN 'IMPOSSIBILITY TO OBTAIN TRANSPORT' TO THE CAPITAL OF BOSNIA-HERZEGOIVNA, BUT EXPRESSED A READINESS FOR THE CONFERENCE TO 'BE HELD WHERE AND WHEN POSSIBLE.'

Dear Mr. President:

As per our conversation this morning, I am forwarding to you what I believe, as a member of the Serbian-American community, must be done to salvage Serbia's reputation in the international community.

As you are no doubt aware, the international press has labeled Serbia as the aggressor in the fighting in Bosnia. More recently, the United States government, the European Community, and the Helsinki Commission have adopted the same position. As the attached "Dear Colleague" indicates, this same position is rapidly taking hold among a growing number of Members of Congress as well.

Although you raise a number of points to counter the criticism directed at Serbia, this is not enough, even for a beginning. Serbia's position has never been more precarious, and the time for extraordinary measures has arrived.

You advised me that tomorrow the Serbian Assembly will have under consideration the new Yugoslav constitution. As explained to me, this legislation essentially reconstitutes the nation of Yugoslavia as comprising the republics of Serbia and Montenegro. I urge that at the same time, you publicly adopt the following recommendations to deflect further criticism from Serbia:

- 1. Publicly appeal, if possible joined by Patriarch Pavle and other political and religious leaders, for an immediate cessation of all hostilities, to be followed by negotiations to ensure the human rights of citizens of all ethnic groups.
- 2. Call upon the United States, the European Community, and/or the United Nations to participate in these negotiations as unbiased arbitrators for the purpose of ensuring guarantees for the protection of minority rights.
- 3. Proclaim your support for the inviolability of Bosnia's borders through use of force.
- 4. Proclaim that the army of the new Yugoslavia has no existence outside the borders of the new federation.

- 5. Call upon all citizens of the Republic of Serbia serving in the Yugoslav Army in Bosnia to return to Serbia as well as all citizens of Croatia involved in the current unrest in Bosnia to return to Croatia.
- 6. Renounce any Federal Army units that claim to be the Yugoslav Army, but remain on Bosnian territory. And in the same vein, the Bosnian border should be sealed with respect to movement of troops or armaments from any other republic or state.
- 7. Invite the people of Bosnia to choose participation in the new federation of Yugoslavia through a plebiscite of voters of all ethnicities.
- 8. Proclaim that the right of self-determination should apply to Serbs in Bosnia and the Krajina region of Croatia.
- 9. In conclusion, state that the Republic of Serbia offers and agrees to do the above in a sincere effort to once and for all perfect a peaceful resolution of all problems, in Yugoslavia and/or its parts, by immediate recognition and removal of all embargoes, sanctions of any and all kinds, on it or its parts.

This is what must be done. Time is of the essence, and unless the Republic of Serbia enacts these recommendations as a package in conjunction with the adoption of a new constitution, I believe that Serbia will pay an even heavier price.

I look forward to discussing the points with you as soon as possible.

Incidentally, I am told that Dragash does NOT have an American passport. His passport is Yugoslavian. The children have American passports.

We do have another emergency humanitarian case that I hope you will take a special interest in and keep me advised of the progress.

Marin Pesa, an American, was captured on March 18 at Bileca (spelling may not be correct) by the Serbians. He was moved to Titograde and now is in Belgrade.

It is important that he is released as soon as possible and you can make the condition that he leaves the area altogether. Although he is a New Yorker and, therefore, a constituent of Senator D'Mato's, I still urge that he be freed as it will do a world of good public relations for you without costing you anything.

These two cases outlined above can do a lot of good for Serbia in the humanitarian line if we can get them worked out.

Will appreciate hearing from you on either or both of these in the very near future.

I made several attempts to telephone you today, but was unable to get through. I am contacting you via facsimile instead.

The House today passed a bill withdrawing Most Favored Nation (MFN) status from the Federal Republic of Yugoslavia. This may not seem much on top of the current sanctions that the international community and the United States have already placed on Yugoslavia, but it is going to make life in Serbia and Montenegro just that much harder for the people, and make new Yugoslavia's economic recovery that much more difficult.

Congressman Phil Crane and myself spoke in opposition to this bill, but current Congressional sentiment is overwhelmingly anti-Serbian, and there was no real chance of defeating this bill. It seems that everyday, here and in other legislative forums, that Serbia is taking harder and harder hits. It has reached a stage where it is becoming impossible for me to defend Serbia's actions.

When I visited in May, I came for a specific purpose, and I backed off. Now, however, for the sake of the Serbian people, and of Yugoslavia, I am joining the chorus to request that you step down as President of the Republic of Serbia. The destruction of Serbia must stop, and this is the only way that is acceptable to the international community.

I will do all in my power to ease your transition from power, and to push for removal of sanctions from Yugoslavia. If it is your wish, I am willing to travel to Belgrade to discuss this with you. I understand your concern for the Serbian people, and I share that concern, but now it is time for a radical change to ensure their continued health and viability.
